3. Briefing on the status of the proposed 2017-2022 Bond Program

Richard Keith updated the board on the housing bond process. On August 10th, city staff briefed City Council in B Session regarding the overall bond package. City Council is considering a total bond package of 850 million for 2017-2022. Proposed bond Program categories include, Streets, Bridges & Sidewalks, Drainage & Flood Control, Parks & Recreation, Facilities & Improvements, and Neighborhood Improvements. The Mayor has appointed the Bond Tri-Chairs for the bond preparation process, Daryl Bird, Eddie Alderete, and Carry Baker.

<u>Peter Zanoni</u> stated there will be bond community meetings. The council members will have meeting with community members routinely to get input.

Carol Rodriguez requested an update on the possibility of including Community Land Trust.

4. Briefing and discussion on the status of the FY2016 Housing Commission Work Plan

Chris Lazaro briefed and updated the board on the FY2016 Work Plan.
