**Amendment #3**

The Department of State Health Services (DSHS) and San Antonio Metropolitan Health District (Contractor) agree to amend Contract ID 2014 045668-001B (Contract), which was effective on July 1, 2014.

- I. The Parties agree to amend Section 4 of the Core Contract and the term of the Program Attachment to extend the end date of the Contract term to September 30, 2016.
- II. The Parties agree to amend Section 1, paragraph B of the Program Attachment to revise item 4 and add a new item 8 as follows:
  4. For clients diagnosed with LTBI (positive IGRA and normal CXR), draw blood draw for baseline labs including a complete metabolic panel (CMP) and a complete blood count (CBC) and send to South Texas Lab, or approved commercial lab. DSHS will provide reimbursement for supplies and lab fees.
  8. Provide alternate recognized treatment for treating LTBI if the 12 dose, 12 week regimen is not appropriate.
- III. The Parties agree to amend Section 2 of the Core Contract to increase the total amount of the Contract to an amount not to exceed \$2,405,040.00
- IV. The Parties agree that the Contractor will report monthly progress of activities to DSHS on the 10<sup>th</sup> of every month. The first report is due on February 10, 2016.
- V. The Parties agree that the mid-year report will be submitted by Contractor to DSHS by April 15, 2016.
- VI. The Parties agree to amend Section II, paragraph B of the Program Attachment to extend the due date of the end of the year report to November 15, 2016.
- VII. The Parties agree to amend Section VI of the Program Attachment to add the Financial Status Report (FSR) dates for the Seventh Quarter period from January 1, 2016 to March 31, 2016, and due on April 29, 2016.

VIII. The Parties agree to amend Section VI of the Program Attachment by adding the FSR dates for the Eighth Quarter period from, April 1, 2016 to June 30, 2016 and due on July 29, 2016.

IX. The Parties agree to amend Section VI of the Program Attachment by adding the FSR dates for the Ninth Quarter period from July 1, 2016 to September 30, 2016 and due on October 31, 2016.

X. Except as provided in this Amendment, all other terms and conditions in the Contract will remain and be in full effect.

XI. This Amendment will be effective as of January 1, 2016
