WHEREAS, City Council desires to initiate a change in the zoning district boundary for property in the San Antonio International Airport Vicinity Land Use Plan, generally located along Turbo Drive and Braniff Drive to a zoning district consistent with the current land use and the surrounding neighborhood in accordance with the Texas Local Government Code Chapter 211 and Chapter 35 of the City Code of San Antonio, Texas, as requested by Councilmember Joe Krier, District 9; NOW THEREFORE;

## BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** City Council hereby directs City staff to initiate a change in the zoning district boundary for property in the San Antonio International Airport Vicinity Land Use Plan, generally located along Turbo Drive and Braniff Drive, to a zoning district consistent with the current land use and the surrounding neighborhood.

**SECTION 2.** This resolution shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
