## AN ORDINANCE 2016-09-29-0756

AUTHORIZING THE EXECUTION OF A FUNDING AGREEMENT WITH THE IDEA PUBLIC SCHOOL AND ACCEPTING FUNDS IN THE AMOUNT NOT TO EXCEED \$40,064.00 FOR THE CITY'S CONSTRUCTION AND INSTALLATION OF THREE SETS OF ADVANCED WARNING FLASHERS ADJACENT TO IDEA PUBLIC SCHOOL CAMPUS LOCATED AT 6919 S. FLORES STREET IN COUNCIL DISTRICT 3.

WHEREAS, the City has a School Flashing Beacon Challenge funded through the Advanced Transportation District (ATD) Program and schools interested in installing flashing beacons or upgrading existing roadside mounted flashing beacons to an overhead mast arm flashing beacon are eligible to receive a 50% match from the City; and

WHEREAS, IDEA Public School is an elementary school located at 6916 S. Flores Street in Council District 3 and adjacent to the school property on the north and south side is West Harding Boulevard and Ware Boulevard; and

WHEREAS, IDEA Public School on South Flores Street is interested in completing the installation of three sets of flashing beacon assemblies to include; two roadside mounted solar powered flashing beacons along West Harding Boulevard; two roadside mounted solar powered flashing beacons along Ware Boulevard; and two overhead mast arm mounted solar power flashing beacons along South Flores Street; and

WHEREAS, IDEA has requested the City's services to construct and install the necessary equipment for the flashing beacon assemblies to help draw motorist attention to the existing school warning signs; and

WHEREAS, the total cost of \$80,128.00 is estimated for construction and installation of the three sets of flashing beacon assemblies and 50% (\$40,064.00) of the total amount will be funded by IDEA Public School South Flores with the remaining 50% to be provided by the City; and

WHEREAS, this Ordinance authorizes the execution of a funding agreement with the IDEA Public School South Flores and accepts funds in an amount not to exceed \$40,064.00 for the construction and installation of three sets of flashing beacon assemblies adjacent to IDEA Public School South Flores; and

## **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The City Manager or her designee is hereby authorized to execute a Funding Agreement with the **IDEA Public School** located at 6916 S. Flores Street and accepting an amount not to exceed \$40,064.00 for the construction and the installation of three sets of flashing beacon assemblies adjacent to the school.

**SECTION 2.** The following financial adjustments are hereby approved:

- a) Funds are authorized to be received from **IDEA Public School** to SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01471, ATD FY 2016 Pedestrian Safety, and the budget shall be revised by increasing WBS element 23-01471-90-10-01, IDEA Public School Contribution and SAP General Ledger 4502280, Contribution from other Agencies, in the amount of \$40,064.00.
- b) The amount up to \$40,064.00 is appropriated in SAP Fund 45099000, General Obligation Capital Projects, SAP Project Definition 23-01471, ATD FY 2016 Pedestrian Safety, SAP WBS Element 23-01471-05-02-01, entitled School Flashing Beacons, SAP GL Account 5201140.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
