AN ORDINANCE

AWARDING A CONSTRUCTION CONTRACT IN AN AMOUNT NOT TO EXCEED \$9,216,350.00 TO J3 COMPANY, LLC FOR PACKAGE 4 OF THE RUNWAY 12R REHABILITATION AND TERMINAL AREA TAXIWAYS IMPROVEMENTS PROJECTS AT SAN ANTONIO INTERNATIONAL AIRPORT.

WHEREAS, in June 2016 City Council authorized the submission of a grant application and the acceptance of funds for a Federal Aviation Administration Airport Improvement Program grant for the Runway 12R Rehabilitation, Terminal Area Taxiways, and Perimeter Road Reconstruction Projects at San Antonio International Airport (SAT); and

WHEREAS, the City received four bids in response to an Invitation for Bid released in May 2016; and

WHEREAS, this Ordinance accepts the lowest responsive bid submitted by J3 Company, LLC in the amount not to exceed \$9,216,350.00 for the Runway 12R Rehabilitation, Terminal Area Taxiways, and Perimeter Road Reconstruction Projects at SAT; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The lowest responsive bid by J3 Company, LLC (J3) in the amount not to exceed \$9,216,350.00 for Package 4 of the Runway 12R Rehabilitation and Terminal Area Taxiways Improvements Projects at San Antonio International Airport is hereby accepted. All other bids will be considered rejected upon execution of a contract by the successful bidder and the deposit of all required bonds and insurance certificates or the expiration of ninety (90) days from the effective date hereof, whichever comes first.

SECTION 2. SECTION 14. A Payment in an amount not to exceed \$5,629,595.00 in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00178, Runway 12R Rehabilitation, is authorized to be encumbered and made payable to J3, for construction services.

SECTION 15. A Payment in an amount not to exceed \$3,586,755.00 in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00193, Terminal Area Taxiways, is authorized to be encumbered and made payable to J3, for construction services.

SECTION 16. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 17. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
