United States Congress

- 115th Congress will convene on January 3, 2017 for a two year legislative session ending January 3, 2019
- Senate: 100 members
- House of Representatives:435 members



114th Congress Recap



- Continued political gridlock 229 Bills passed to date
- 12 appropriations bills did not pass
- Short term CR passed Sept. 28 funding government until Dec. 9



Nov. 14 - Dec. 16 "lame duck" session is likely to see
 a flurry of legislative activity

Political Landscape

- 2016 Election (November 8)
 - Presidential election determines which party controls executive branch
 - Congressional elections determines which party controls the Senate and House for the next two years
- 34 Senate seats up for election
- All 435 Representative seats up for election
- Texas' 23rd Congressional District only competitive seat in State



Political Landscape

- Nov. 29 Dec. 16 "Lame duck" session with final action on FY 2017 appropriations and election of Congressional party leadership
- Nov. 2016 Jan. 2017 Presidential transition teams prepares comprehensive recommendations on programs and initiatives
- January 3, 2017 First day of 115th Congress
- January 20, 2017 Presidential inauguration
