AN ORDINANCE 2016-10-20-0813

AUTHORIZING THE EXECUTION OF A FIRST RENEWAL TO LEASE AGREEMENT BETWEEN THE CITY OF SAN ANTONIO AND CATHOLIC LIFE INSURANCE FOR OFFICE SPACE LOCATED WITHIN THE CATHOLIC LIFE BUILDING AT 1635 N.E. LOOP 410, SUITE 510 IN CITY COUNCIL DISTRICT 10, FOR USE AS THE DISTRICT 10 CONSTITUENT OFFICE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee, severally, are authorized and directed to execute and deliver on behalf of the City a lease renewal agreement substantially in the form of **Attachment I**, which is incorporated by reference for all purposes as if fully set forth. The City Manager and designee, severally, should take all other actions reasonably necessary or convenient to effectuate the transaction, including agreeing to non-material changes to the approved form and executing and delivering all ancillary instruments and agreements conducive to effectuating the transaction.

SECTION 2. Funding in the amount of \$17,600.00 for this Ordinance is available for Fund 11001000, Cost Center 110010001, and General Ledger 5206010, as part of the Fiscal Year 2017 Budget.

SECTION 3. Payment not to exceed the budgeted amount is authorized - Catholic Life Insurance and should be encumbered with a purchase order. All expenditures will comply with the approved operating budget for current and future fiscal years.

SECTION 4. Additional funding for this ordinance is contingent upon City Council approval of the City's operating budget and the availability of funds for Fiscal Years 2018, 2019, 2020, 2021 and 2022.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.


