 CMR is a delivery method which entails a commitment by the Construction Manager (CM) to deliver the project within a Guaranteed Maximum Price (GMP) which is based on the construction documents and specifications at the time of the GMP.



 Selected CRM respondent shall work with the design consultant in the preparation of the design and will coordinate with TCI, HPARC and other entities involved in the project


