Storm Water System Televising, Mapping and Condition Assessment (TCI) - Department issued a Request for Qualifications seeking qualified firms to perform Storm Water Televising, mapping and condition assessment. The scope of the project will include: locating underground and surface structures including manholes, inlets, pipes, and culverts. Perform panoramic CCTV inspection of the structures and place data into City's software. Assess, rate, record structures, and map City's storm water drainage infrastructure.

Annual Contract for Rigging Services (CSF) - Department issued a Request for Competitive Sealed Proposals seeking qualified, professional companies to manage and provide rigging services for the Alamodome. City will provide rigging materials such as cables, chain hoist, stack chain, shackles, trusses, etc. Contractor will provide labor, tools and equipment to assemble and install rigging materials. Rigging services are provided to transition one event to another at the Facility, and for other special projects or maintenance and repair tasks. The Contractor will engineer, plan, layout, and calculate formulas and principals to suspend, from the Alamodome ceiling, facility and event production, sound and lighting equipment such as banners, trusses, curtain systems and any other installations. Contractor will be responsible for City-owned and Contractor-owned equipment.
