

ISSUES

- On September 3, 2015 City Council adopted an Ordinance to change Old Hwy to Enrique M Barrera Pkwy with the memorial designation of “Historic Old Hwy 90”.
- All of the signs on the COSA surface streets have been changed to Enrique M Barrera Pkwy and the citizens have begun to change their addresses.
- TXDOT has manufactured and installed 2 of the 17 signs along U.S. Hwy 90 and State Hwy 151.



Fiscal Impact

- Application Fee: \$1,000.00
- Notification Fee: \$1,044.00
- Signage Fee:
 - TXDOT – 10,000.00 2 of 17 signs-(estimate)
 - COSA – 20,000.00 148 signs – (estimate)
- Total: \$32,044.00 (estimate)
- All fees were paid by the applicants



Public Notice

- Approximately 181 properties will require an address change
 - 151 Commercial
 - 30 Residential
- 232 notices mailed to adjacent property owners
 - 73 in favor
 - 0 in Opposition



RECOMMENDATION

- The Planning Commission, at its meeting of August 10, 2016 continued the item for two weeks at the applicants' request.
- Planning Commission recommended approval on August 24, 2016.
- Staff recommends **denial**
 - **Similar names may increase emergency response times**
 - **Financial hardships to property owners**
