AN ORDINANCE

AUTHORIZING A PERMIT FOR THE INSTALLATION OF SIGN(S) WITHIN LA CANTERA PKWY, PUBLIC RIGHT OF WAY BETWEEN IH-10 AND LOOP 1604 IN COUNCIL DISTRICT 8, AS REQUESTED BY USAA REALCO FOR A FEE OF \$500.00; AND WAIVING APPLICABLE SECTIONS OF CHAPTER 28 AND CHAPTER 37 OF THE CITY CODE.

WHEREAS, USAA Realco is requesting a permit for a 10-year term for the installation and maintenance of wayfinding signs within La Cantera Pkwy; and

WHEREAS, USAA Realco is the owner of the abutting property along the streets including the Shops at La Cantera and would like to replace and add new signage that would conform to the existing aesthetic to better serve residents and visitors locate their destinations through easy to read wayfinding; and

WHEREAS, this Ordinance authorizes a permit for the installation of signs within La Cantera Pkwy, public right of way between IH-10 and Loop 1604 in Council District 8, as requested by **USAA Realco** for a fee of \$500.00; and waiving applicable sections of Chapter 28 and Chapter 37 of the City Code; and

WHEREAS, a total of 70 signs are being proposed, 66 being replaced, while 14 new signs are being added; and

WHEREAS, as provided by Chapter 37, Section 22 of the City Code the required permit fee is \$500.00. This revenue will be deposited into the Signage installation the General Fund in accordance with the FY 2017 Adopted Budget; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is hereby authorized to execute a Permit to **USAA Realco** for the installation of 70 signs within La Cantera Parkway, public right of way between IH-10 and Loop 1604 for a fee of \$500.00 and waiving applicable sections of Chapter 28 and Chapter 37 of the City Code.

SECTION 2. The following financial adjustments are hereby approved:

- a) Funds generated by this Ordinance will be deposited into Fund 11001000, Internal Order 223000000254 and General Ledger 4202410.
- b) The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence

by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 3. This Ordinance shall be effective immediately upon passage by eight or more affirmative votes; otherwise, it shall be effective on the tenth day after passage.
