AN ORDINANCE **2016-12-01-0950**

AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF SAN ANTONIO BY AMENDING CHAPTER 35, UNIFIED DEVELOPMENT CODE, SECTION 35-304, OF THE CITY CODE OF SAN ANTONIO, TEXAS BY CHANGING THE ZONING DISTRICT BOUNDARY OF CERTAIN PROPERTY.

WHEREAS, a public hearing was held after notice and publication regarding this amendment to the Official Zoning Map at which time parties in interest and citizens were given an opportunity to be heard; and

WHEREAS, the Zoning Commission has submitted a final report to the City Council regarding this amendment to the Official Zoning Map of the City of San Antonio; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Chapter 35, Unified Development Code, Section 35-304, Official Zoning Map, of the City Code of San Antonio, Texas is amended by changing the zoning district boundary of 11.242 acres out of NCB 34721 from "C-3 MLOD-1 MSAO-1 AHOD" General Commercial Camp Bullis Military Lighting Overlay Camp Bullis Military Sound Attenuation Overlay Airport Hazard Overlay District and "C-2 MLOD MSAO-1 AHOD" Commercial Camp Bullis Military Sound Attenuation Overlay Camp Bullis Military Sound Attenuation Overlay Airport Hazard Overlay Camp Bullis Military Camp Bullis Military Lighting Overlay Camp Bullis Military Sound Attenuation Overlay Airport Hazard Overlay District to "R-6 MLOD-1 MSAO-1 AHOD" Residential Single-Family Camp Bullis Military Lighting Overlay Camp Bullis Military Camp Bullis Military Lighting Overlay Attenuation Overlay Airport Hazard Overlay District to "R-6 MLOD-1 MSAO-1 AHOD" Residential Single-Family Camp Bullis Military Lighting Overlay Camp Bullis Military Camp Bullis Military Lighting Overlay Attenuation Overlay Airport Hazard Overlay Camp Bullis Military Camp Bullis Military Lighting Overlay Camp Attenuation Overlay Airport Hazard Overlay Camp Bullis Military Sound Attenuation Overlay Airport Hazard Overlay District.

SECTION 2. A description of the property is attached as **Exhibit "A"** and made a part hereof and incorporated herein for all purposes.

SECTION 3. All other provisions of Chapter 35 except those expressly amended by this ordinance shall remain in full force and effect including the penalties for violations as made and provided for in Section 35 -491.

SECTION 4. The Director of Development Services shall change the zoning records and maps in accordance with this ordinance and the same shall be available and open to the public for inspection.

SECTION 5. This ordinance shall become effective the 10th day of December 2016.

METES AND BOUNDS DESCRIPTION FOR ZONING

A 11.242 acre, or 489,702 square feet more or less, tract of land out of a 23.62 acre tract described in Deed to La Cantera Development recorded in Volume 8190, Pages 1875-1880 of the Official Public Records of Bexar County, Texas, out of the S.R. Roberts Survey No. 22¹/₂, Abstract 640, County Block 4721, now in New City Block (N.C.B) 34725 of the City of San Antonio, Bexar County, Texas. Said 11.242 acre tract being more fully described as follows, with bearings based on the Texas Coordinate System established for the South Central Zone from the North American Datum of 1983 NAD 83 (NA2011) epoch 2010.00;

- BEGINNING: At a found ½" iron rod with a yellow cap marked "Pape-Dawson" at the east end of the southeast return at the intersection of Camp Bullis Road, a 86-foot public right-of-way, dedicated in Volume 9510, Pages 187-190 of the Deed and Plat Records of Bexar County, Texas and Babcock Road, a variable width public rightof-way, and a northwest corner of said 23.62 acre tract;
- THENCE: N 68°38'46" E, with the southeast right-of-way line of said Camp Bullis Road, the northwest line of said 23.62 acre tract, a distance of 747.88 feet to a point;
- THENCE: Departing the southeast right-of-way line of said Camp Bullis Road, over and across said 23.62 acre tract the following bearings and distances:

S 03°58'29" E, a distance of 167.65 feet to a point;

S 07°18'12" W, a distance of 252.10 feet to a point;

S 18°16'20" W, a distance of 421.74 feet to a point;

S 42°48'33" W, a distance of 165.19 feet to a point;

S 57°12'26" W, a distance of 261.62 feet to a point on the east right-of-way line of said Babcock Road and the west line of said 23.62 acre tract;

THENCE: With the east right-of-way line of said Babcock road and the west line of said 23.62 acre tract, the following bearings and distances:

Northwesterly, along a non-tangent curve to the left, said curve having a radial bearing of S 68°32'24" W, a radius of 715.80 feet, a central angle of 03°57'01", a chord bearing and distance of N 23°26'07" W, 49.34 feet, for an arc length of 49.35 feet to a found ¹/₂" iron rod with a yellow cap marked "Pape-Dawson";

N 25°24'37" W, a distance of 127.65 feet to a found ¹/₂" iron rod with a yellow cap marked "Pape-Dawson";

Northwesterly, along a tangent curve to the right, said curve having a radius of 1383.21 feet, a central angle of $20^{\circ}29'24''$, a chord bearing and distance of N 15°09'55'' W, 492.03 feet, for an arc length of 494.66 feet to a found ½'' iron rod with a yellow cap marked "Pape-Dawson";

Northwesterly, along a reverse curve to the left, said curve having a radius of 933.98 feet, a central angle of 08°56'18", a chord bearing and distance of N 09°23'22" W, 145.56 feet, for an arc length of 145.71 feet to a found ½" iron rod with a yellow cap marked "Pape-Dawson" at the south end of aforementioned return;

THENCE: Northeasterly, along a reverse curve to the right, said curve having a radius of 25.00 feet, a central angle of 82°30'18", a chord bearing and distance of N 27°23'37" E, 32.97 feet, for an arc length of 36.00 feet to the POINT OF BEGINNING, and containing 11.242 acres in the City of San Antonio, Bexar County, Texas. Said tract being described in accordance with an exhibit prepared under job number 9024-16 by Pape-Dawson Engineers, Inc.


