AN ORDINANCE 2016-12-08-0969

AMENDING CHAPTER 3, ARTICLE II, SECTION 3-180 OF THE CITY CODE OF SAN ANTONIO, TEXAS, TO AMEND THE FEES

* * * * *

WHEREAS, vehicle for hire services allow people to visit the City of San Antonio for business and for pleasure, and enhance the enjoyment and experiences of those who visit by allowing access to the different areas of the City; and

WHEREAS, vehicle for hire services are likewise convenient and necessary for many residents of the City of San Antonio for business and pleasure, and for essential personal and family needs including food and medical care; and

WHEREAS, after careful consideration, the City Council has determined that it is in the best interest of the citizens of the City of San Antonio to amend Chapter 3 of the City Code of San Antonio, Texas (City Code) to modify the fees due to the city; and

WHEREAS, in order to accomplish such revisions, it is necessary to modify Chapter 3 of the City Code, Vehicles for Hire, in Article II, Section 3-180; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Chapter 3, Article II, Section 3-180 of the City Code is hereby amended as stated in accordance with Attachment C, which is incorporated herein in its entirety, with strikethroughs indicating deletions and underlines indicating additions.

SECTION 2. The remainder of City Code Chapter 3 shall remain in full force and effect, save and except as amended by this ordinance.

SECTION 3. Funds generated by this ordinance will be deposited into Fund 51001000, Internal Order 233000000079 and General Ledger 4405921.

SECTION 4. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 5. Should any portion of this ordinance for any reason be held illegal, inoperative, invalid, unconstitutional or ineffective, the remainder shall, nevertheless, stand effective and valid as if it had been enacted or ordained without the portion held to be illegal, inoperative, invalid, unconstitutional or ineffective.

- Sec. 3-180. Payment of ground transportation <u>airport operating permits and per trip</u> fees by class.
- (a) The aviation department is hereby authorized to implement a permit system and to collect ground transportation fees from certain classes of commercial vehicles operating at San Antonio International Airport. This includes collecting the airport operating permit fee as established in chapter 33 of this Code.

(b) The airport permit fees, to be paid annually, shall be as follows:
