<u>Dangerous Premises</u> – properties and structures that are unoccupied and/or unsecured that pose a danger to public health and/or safety OR has been vandalized by graffiti



Seeking 4 contractors to clean and secure said dangerous premises

Project Scope

Clear and Mow Properties

- Contractor shall pick up and legally dispose of any and all brush, tree limbs, leaves, grass/weed clippings, trash, rubbish and debris
- Contractor shall mow properties to less than 3"

Secure Structures as Needed

 Any accessible doors or windows shall be boarded and secured, including windows and doors with burglar bars

Abate for Graffiti

 All structures, objects and/or fences that have been vandalized with graffiti shall be painted
