# AN ORDINANCE 2017-01-19-0030

**AUTHORIZING THE EXECUTION OF AMENDMENT #1** TO THE LICENSE AGREEMENT WITH SPORTI FOR A **10-YEAR TERM EXTENSION TO COMMENCE UPON** SOCCER **FIELD** THE **COMPLETION** OF IMPROVEMENTS AT PEARSALL PARK LOCATED IN COUNCIL DISTRICT NO CITY FUNDS 4; ARE ASSOCIATED WITH THIS ACTION.

WHEREAS, Pearsall Park was dedicated as parkland in 1999 and sits upon a former landfill; and

WHEREAS, since then, through land acquisitions, the park has grown to 500 acres; and

WHEREAS, the 2012 Bond Program appropriated \$7.5 million for improvements to Pearsall Park consistent with the park's master plan and input from the community which include amenities such as Family Fun and Fitness Challenge Zones, pavilions, a new playground facility, splash-pad, and skate-park; and

WHEREAS, since Pearsall Park's opening to the public in June 2016, it has quickly transformed into a regional destination; and

WHEREAS, in December 2015, City Council approved a sports license agreement that allowed the Parks and Recreation Department to partner with SPORTi in their development, operation, and maintenance of soccer fields at Pearsall Park which will serve youth and adults and those with special needs on a weekly basis; and

WHEREAS, continued development of new park improvements to include partnerships with groups such as SPORTi, will allow for an increase in the types of amenities and programs that are available to the community; and

WHEREAS, specifically, SPORTi's license agreement allows for installation of lighting, irrigation, and spectator seating to existing soccer fields at no cost to the City; and

WHEREAS, SPORTi has secured the required Texas Commission on Environmental Quality (TCEQ) site work permits and completion of soccer field improvements is projected in April 2017; and

WHEREAS, the license agreement with SPORTi is being amended in order to accommodate the revised construction schedule and the term of the agreement will be extended from a three (3) year term with one-year administrative renewal options to a ten (10) year term to commence immediately upon completion of soccer field improvements; and

WHEREAS, this term extension of SPORTi's license agreement will facilitate SPORTi's compliance with Fédération Internationale de Football Association operating standards; NOW THEREFORE:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or her designee or the Director of the Parks and Recreation Department or his designee is authorized to execute Amendment 1 to the license agreement with SPORTi for a 10-year term extension to commence upon the completion of soccer field improvements at Pearsall Park located in Council District 4. A copy of the amendment in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

**SECTION 2.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 3**. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.

## AMENDMENT #1 TO THE SPORTS LICENSE AGREEMENT WITH SPORT: DESARROLLO DEPORTIVO FOR SOCCER FIELDS AT PEARSALL PARK

This Amendment to the Sports License Agreement ("Agreement") is made and entered into as of the \_\_\_\_\_\_ day of \_\_\_\_\_\_, 20\_\_\_\_, by and between the City of San Antonio, a Texas municipal corporation, acting by and through its City Manager or her designee pursuant to Ordinance No. \_\_\_\_\_\_ dated \_\_\_\_\_\_, 20\_\_\_\_ (herein called "City"), and SPORTi Desarrollo Deportivo, a for-profit corporation registered and operating through its General Director, Sandra Paula Carrera de la Pena, (herein referred to as "League");

#### 1. PREAMBLE

- 1. WHEREAS, as part of the park's appropriations from the 2012 Bond, improvements to Pearsall Park were completed in the summer of 2016 as consistent with the park's master plan and with input from the community; and
- WHEREAS, concurrent to the park improvements made as a result of the 2012 Bond project, the City executed a sports license agreement with League for additional improvements, operational programming and maintenance of soccer fields to activate areas at Pearsall Park for the benefit of the citizens; and
- 3. WHEREAS, to comply with League's required Fédération Internationale de Football Association (FIFA) standards, City and League desire to extend the term of the Agreement for a ten (10) year term to commence immediately upon completion of League's Immediate Capital Improvements subject to approval by the City's Parks and Recreation Department,

Now, therefore, for and in consideration of the premises City and League do hereby amend the Sports License Agreement as follows:

## 2. TERM OF LICENSE AGREEMENT

Section 3. "Term of License Agreement" is hereby amended as follows:

#### 3.2 Is hereby deleted and replaced with the following:

"The term of this Agreement shall be extended for a ten (10) year term to commence immediately upon League's completion of City approved Immediate Capital Improvements, subject to the terms stated in Section 8.5 of this Agreement."

### CAPITAL IMPROVEMENTS

Section 8. "Term of License Agreement" is hereby amended as follows:

8.5 "Immediate Capital Improvements," paragraph one (1) is hereby deleted and replaced with the following:

"Immediate Capital Improvements: All Immediate Capital Improvements shall be made at no cost to the City and shall be completed by April 30, 2017. League may request an extension of the planned timeline for Immediate Capital Improvements, subject to prior written approval by the City through its Director of the Parks and Recreation Department."
