

AN ORDINANCE 2017-02-09-0070

AUTHORIZING THE ACCEPTANCE OF A GRANT IN AN AMOUNT UP TO \$33,639.60 FROM THE SOUTHWEST TEXAS REGIONAL ADVISORY COUNCIL FOR TRAUMA FOR USE BY THE EMERGENCY MEDICAL SERVICES DIVISION OF THE SAN ANTONIO FIRE DEPARTMENT FOR ELIGIBLE EXPENSES INCLUDING SUPPLIES, OPERATIONAL EXPENSES, EDUCATION AND TRAINING, EQUIPMENT, VEHICLES AND COMMUNICATION EQUIPMENT.

WHEREAS, the Southwest Texas Regional Advisory Council for Trauma (STRAC) has awarded grant funds in the amount of \$33,639.60 to the San Antonio Fire Department (SAFD) to be used for Emergency Medical Services (EMS) Division eligible expenses including supplies, operational expenses, education and training, equipment, vehicles and communication equipment; and

WHEREAS, no cash or in-kind matching contributions are required; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee are hereby authorized to accept grant funds in the amount of \$33,639.60 from the STRAC that will be used by the SAFD EMS Division for eligible expenses including supplies, operational expenses, education and training, equipment, vehicles and communication equipment. The City Manager and her designee are further authorized to execute any and all documents necessary to effectuate said acceptance.

SECTION 2. Fund 2201620000 entitled "STRAC Grant 2017" and internal order 120000000123 are hereby designated for use in the accounting for the fiscal transaction in the acceptance of this grant. The sum of \$33,639.60 from the STRAC will be appropriated in said fund. A formal final budget will be provided upon acceptance of funds.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
