**AN ORDINANCE**

**AMENDING THE MASTER INTERLOCAL AGREEMENT WITH  
BEXAR COUNTY TO UPDATE THE REQUIREMENTS,  
DELIVERABLES AND COMPENSATION RELATED TO CRIME  
LAB/MEDICAL EXAMINER, HOTEL OCCUPANCY TAX  
COLLECTION, MAGISTRATION AND TRUANCY SERVICES.**

**WHEREAS**, in the interest of efficiency and effective provision of services, City Council approved Ordinance No. 2013-08-15-054 authorizing a Master Interlocal Agreement (“Agreement”) with Bexar County for the provision of numerous services, including crime lab/medical examination, hotel occupancy tax collection, and magistration services and the Agreement was later amended to include truancy services by the passage of Ordinance No. 2014-05-29-0380 (collectively “Services”); and

**WHEREAS**, the proposed amendment to the Agreement updates operational requirements, deliverables, and compensation necessitated by changes in the law and needs of the parties and caps the Magistration Mental Health Assessment Escort Services at \$64,498 per fiscal year;  
**NOW THEREFORE:**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The terms and conditions of the First Amendment to Addendum A-6, Crime Lab/Medical Examiner, Addendum A-8, Magistrate, Addendum A-9, Hotel Tax, and Addendum A-11, Uniform Truancy Case Management Program, are authorized and approved. The City Manager or her designee is authorized to execute the Amendment, a copy of which, previously executed by Bexar County, is attached to this Ordinance as **Exhibit I**.

**SECTION 2.** Funding in the amount of \$2,519,975 for this Ordinance is available in Fund 11001000, Cost Center 1706020002 and General Ledger 5201040.

**SECTION 3.** The amount up to \$ 2,519,975 will be encumbered upon issuance of purchase orders, and payment is authorized to Bexar County. All expenditures will be in accordance with the Fiscal Year 2017 and subsequent budgets that fall within the term of this Agreement.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP

Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance shall take effect immediately upon the receipt of eight affirmative votes; otherwise it shall be effective ten days after its passage.
