AN ORDINANCE

DECLARING 18 CITY OWNED PROPERTIES LOCATED IN COUNCIL DISTRICT 3 ON WOODSTOCK DRIVE, KENSWICK VIEW, TEHAMA GATE, ADAIR BLUFF, SALADO BLUFF, ALSBROOK DRIVE, ANTON DRIVE AND ADA STREET AS SURPLUS, AND 8 CITY OWNED PROPERTIES LOCATED IN COUNCIL DISTRICT 5 ON AZUCENA STREET, SAUNDERS AVENUE, SOUTH PICOSO, EL PASO STREET, JUAREZ STREET, ORIENTAL AVENUE AND ROMERO AS SURPLUS; AND AUTHORIZING THEIR DISPOSITION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager and her designee, severally, are authorized and directed to dispose of the 26 properties shown and described in **Attachment I**, which is incorporated herein for all purposes as if fully stated.

SECTION 2. The City Manager and her designee, jointly and severally, are authorized and directed to sell any of the 27 properties under a disposition process as outlined and allowed under any of the following: Texas Local Government Code §272, Texas Local Government Code §253, Texas Tax Code §34, or Texas Tax Code §311, provided the minimum accepted price may not be lower than the taxes owed to any taxing entities, other than the City of San Antonio, plus court costs. The City Council finds that the consideration received by the City in repayment of any taxes previously owed to it is the benefit derived by the City from the inclusion and use of the properties by citizens and removal of maintenance obligations, which is found and determined to equal or exceed the amount to which the City is currently entitled to receive for such amounts previously owed. However, the City Manager or her designee are not obligated to accept any bid and may require an amount above the amount of taxes or other amounts owed to taxing entities. Further, the City Manager may require outstanding bond debt, funds due back to the Municipal Facility Energy Retrofit Program or any other city expenditure related to the properties be reimbursed prior to conveyance. The City Manager and her designee, severally, are authorized and directed to execute and deliver on behalf of the city a deed without warranty, substantially in the form shown in **Attachment II**, conveying the above-described property for the consideration and under the terms shown as modified by the City Attorney's Office pursuant to the statute under which the property is sold. The City Manager and her designee, severally, are authorized to take all additional actions reasonably necessary or convenient to effectuate the transactions, including executing and delivering all instruments and agreements conducive to effectuating the transaction.


SECTION 3. Funds generated by this ordinance will be deposited into Fund XXXXXXXX, Internal Order XXXXXXXXX and General Ledger XXXXXXXXXX.

SECTION 4. The disposition of property must be coordinated through the City's Finance Department to assure the removal of these assets out of the City's financial records and to record the proper accounting transactions.


SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This ordinance becomes effective 10 days after passage, unless it receives the eight votes requisite to immediate effectiveness under San Antonio Municipal Code § 1-15, in which case it becomes effective immediately.
