AN ORDINANCE 2017-03-30-0187

AUTHORIZING A FUNDNG AGREEMENT IN THE AMOUNT OF \$82,000.00 WITH THE SAN ANTONIO EDUCATION PARTNERSHIP TO BE USED FOR THE UPGRADE INITIATIVE.

WHEREAS, the 2015 SA2020 Talent Pipeline Report highlighted a shortage of trained individuals to fill middle-skilled jobs and identified adults who have some college credits but have not received a degree as a possible solution for the skill gap; and

WHEREAS, the Upgrade initiative is a specific strategy that targets these adults by matching them to career pathways that include continuing their academic careers resulting in the attainment of a degree and placing these individuals on a pathway to higher skilled and higher paying jobs; and

WHEREAS, the Upgrade initiative is done in collaboration with SA Works and is housed within Café College and operated by the San Antonio Education Partnership; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of a Funding Agreement with San Antonio Education Partnership in the amount of \$82,000.00 to be used for the Upgrade initiative are hereby approved.

SECTION 2. The City Manager or her designee is authorized to execute a Funding Agreement with San Antonio Education Partnership to effectuate the purpose of this Ordinance. A copy of the final agreement shall be filed with this Ordinance upon execution.

SECTION 3. Funding in the amount of \$82,000.00 for this ordinance is available in Fund 29059000, Cost Center 1604010001 and General Ledger 5201040 as part of the Fiscal Year 2017 Budget.

SECTION 4. Payment not to exceed the budgeted amount is authorized to Upgrade and should be encumbered with a purchase order.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance shall become effective immediately upon its passage by eight (8) votes or more and upon ten (10) days following its passage if approved by fewer than eight (8) votes.
