

AN ORDINANCE 2017-04-06-0205

AMENDING THE TRAFFIC CONTROL DEVICES SCHEDULES ESTABLISHED BY CHAPTER 19 (TRAFFIC REGULATIONS), ARTICLE III (TRAFFIC CONTROL DEVICES), SECTION 19-68(b) TO INCLUDE CERTAIN ADDITIONS TO THE OFFICIAL TRAFFIC CONTROL DEVICES SCHEDULES FOR "FULL TRAFFIC SIGNAL LOCATIONS", "ONE-WAY AT ALL TIMES" SIGN, "ALL WAY STOP" SIGNS, "CROSS STREET STOP" SIGNS, "MAXIMUM SPEED LIMIT" SIGNS, "PARKING PROHIBITED AT ALL TIMES, INCLUDING SUNDAYS AND HOLIDAYS" SIGNS, "STOPPING, STANDING OR PARKING PROHIBITED SEVEN A.M. TO NINE P.M." SIGNS, "STOPPING, STANDING OR PARKING PROHIBITED FOUR P.M. TO SIX P.M." SIGNS, "STOPPING, STANDING OR PARKING PROHIBITED SEVEN A.M. TO NINE A.M. AND FOUR P.M. TO SIX P.M." SIGNS, "STOPPING, STANDING OR PARKING PROHIBITED SEVEN A.M. TO SIX P.M." SIGNS, "STOPPING, STANDING OR PARKING PROHIBITED SEVEN A.M. TO NINE A.M. AND TWO P.M. TO FOUR P.M. SCHOOL DAYS ONLY" SIGNS, "STOPPING, STANDING OR PARKING PROHIBITED SEVEN A.M. TO NINE A.M. AND TWO P.M. TO FIVE P.M. SCHOOL DAYS ONLY" SIGNS, "SCHOOL ZONES, SCHOOL CROSSWALKS (INTERSECTION), CELL PHONE USE PROHIBITED" SIGNS, "SCHOOL ZONES, SCHOOL CROSSWALKS (MID-BLOCK), FLASHING BEACON, SPECIFIED SPEED, SCHOOL DAYS ONLY, CELL PHONE USE PROHIBITED" SIGNS, "SCHOOL ZONES, SCHOOL CROSSWALKS (INTERSECTIONS), FLASHING BEACON, SPECIFIED SPEED, SCHOOL DAYS ONLY, CELL PHONE USE PROHIBITED" SIGNS, AND CREATING SCHEDULE H(M) "STOPPING, STANDING OR PARKING PROHIBITED SIX P.M. TO SEVEN A.M." SIGNS, AND CREATING SCHEDULE H(N) "STOPPING, STANDING OR PARKING PROHIBITED NINE P.M. TO SIX A.M." SIGNS; AUTHORIZING THE PERMANENT INSTALLATION OF SAID DEVICES; DECLARING THEM AS OFFICIAL TRAFFIC CONTROL DEVICES OF THE CITY OF SAN ANTONIO; AND DECLARING VIOLATIONS OF THESE TRAFFIC REGULATIONS, EXCEPT THE CIVIL PARKING VIOLATIONS, TO BE MISDEMEANOR CRIMES PUNISHABLE BY A FINE OF NOT MORE THAN \$200.00, AND DECLARING VIOLATIONS OF THE CIVIL PARKING VIOLATIONS TO BE SUBJECT TO THE ENFORCEMENT PROVISIONS OF CITY CODE SECTION 19-225 (ADMINISTRATIVE ADJUDICATION OF STOPPING, STANDING AND PARKING VIOLATIONS), AND ESTABLISHING AN EFFECTIVE DATE OF NO MORE THAN 5 DAYS AFTER PUBLICATION IN ACCORDANCE WITH ARTICLE 2, SECTION 17, OF THE CITY CHARTER.

WHEREAS, Chapter 19 of the City Code requires that all official traffic controls, devices, and regulations be established by separate ordinances; and

WHEREAS, there are certain traffic control devices, parking regulations, and other traffic control regulations at certain locations that have been surveyed by traffic engineers, and determined to be necessary for the public safety; and

WHEREAS, Section 19-68 of the traffic regulations in the City Code require that schedules of the various traffic control devices be maintained and kept updated at the Office of the City Clerk; and

WHEREAS, this Ordinance amends the Traffic Control Devices Schedules for the City of San Antonio, established in Chapter 19, Section 68 of the City Code, to add locations where new installations of traffic control devices have occurred, and remove locations where devices have been altered or removed; and

WHEREAS, this Ordinance also will create Schedule H(m) "Stopping, Standing or Parking Prohibited Six P.M. to Seven A.M." and Schedule H(n) "Stopping, Standing or Parking Prohibited Nine P.M. to Six A.M." in order to address residents' parking concerns and impact from nearby commercial areas and activity; and

WHEREAS, parking regulations are enforced through civil penalties, while all other traffic violations are misdemeanor crimes; **NOW THEREFORE**,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Chapter 19 "Motor Vehicles and Traffic", Article III "Traffic Control Devices", Section 19-68(b) is hereby amended to add two new sections to Schedule H as follows:

Schedule H(m): entitled "Stopping, Standing, Or Parking Prohibited Six PM to Seven AM" and

Schedule H(n): entitled "Stopping, Standing, Or Parking Prohibited Nine PM to Six AM"

SECTION 2. Traffic Control Device Schedules enacted through Section 19-68(b) of the City Code of the City of San Antonio are hereby amended and the city clerk is hereby authorized to:

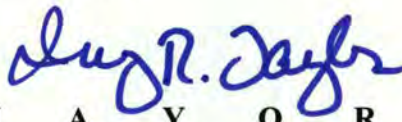

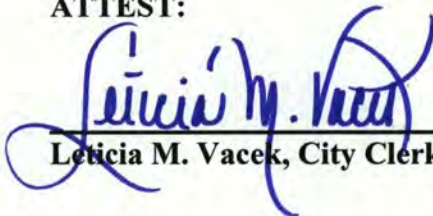

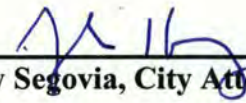
