AN ORDINANCE 2017 - 04 - 06 - 02 04

AUTHORIZING THE SUBMISSION OF AN APPLICATION AND ACCEPTANCE OF FUNDS UPON AWARD IN AN AMOUNT UP TO \$1,000,000.00 FROM THE TEXAS DEPARTMENT **OF TRANSPORTATION** FOR COMPREHENSIVE SELECTIVE TRAFFIC ENFORCEMENT PROGRAM GRANT; AND AUTHORIZING A CASH MATCH CONTRIBUTION UP TO \$265,000.00 AND AN IN-KIND CONTRIBUTION UP TO \$113,650.00 FOR THE PERIOD OF OCTOBER 1, 2017 THROUGH SEPTEMBER 30, 2018.

WHEREAS, the Texas Department of Transportation has grant funds available in an amount up to \$1,000,000.00 for the Comprehensive Selective Traffic Enforcement Program to combat the incidence of driving while intoxicated, speeding, occupant protection, distracted driving and

intersection-related violations; and

WHEREAS, the grant period is from October 1, 2017, through September 30, 2018; and

WHEREAS, a cash match contribution in an amount not to exceed \$265,000.00 and an in-kind contribution in an amount not to exceed \$113,650.00 are required; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the San Antonio Chief of Police or his designee, is hereby authorized to submit a grant application and accept funds upon award in an amount up to \$1,000,000.00 from the Texas Department of Transportation (TxDOT) for funding for the Comprehensive Selective Traffic Enforcement Program (STEP) for the grant period of October 1, 2017 through September 30, 2018. In connection therewith, this Ordinance also authorizes a required cash match contribution in an amount not to exceed \$265,000.00 from the General Fund contingent upon the available of funding in the Fiscal Year 2018 budget and a required in-kind contribution in an amount not to exceed \$113,650.00, which will be fulfilled by San Antonio Police Department (SAPD) vehicles and personnel.

SECTION 2. The City Manager or her designee, or the San Antonio Chief of Police or his designee, is further authorized to execute any and all necessary documents to effectuate said application and acceptance of the referenced grant. A copy of the grant application which is incorporated herein for all purposes is on file with the San Antonio Police Department.

SECTION 3. Upon award, a new fund and internal order will be created for use in the accounting for the fiscal transaction in the acceptance of this grant and the amounts listed above for a total not to exceed \$1,378,650.00 will be appropriated in said funds. A formal final budget which will include Internal Order numbers and General Ledger numbers will be submitted by SAPD upon award.

SECTION 4. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

SECTION 5. This Ordinance is effective immediately upon passage by eight or more affirmative votes; otherwise, it is effective on the tenth day after passage.
