AN ORDINANCE

AUTHORIZING THE SECOND AMENDMENT TO THE FOOD SERVICE AGREEMENT FOR THE ALAMODOME WITH SMG FOOD AND BEVERAGE, LLC, D/B/A SAVOR BLACK TIE JOINT VENTURE.

WHEREAS, Ordinance No. 2016-01-28-0031, approved January 28, 2016, authorized a Food Service Agreement for the Alamodome ("Agreement") with SMG Food and Beverage, LLC d/b/a SAVOR Black Tie Joint Venture ("SAVOR") for catering and concession services and merchandise sales for a variety of events, including sporting events, concerts, and family shows; and

WHEREAS, the City and SAVOR desire to enter into the proposed Second Amendment to the Food Services Agreement ("Second Amendment") in order to clarify and modify certain provisions of the Agreement related to reporting, payment, merchandise sales, and the definition of "branded third-party sales;" **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The terms and conditions of the Second Amendment to the Food Service Agreement with SAVOR are authorized and approved. The City Manager, or her designee, is authorized to execute the Second Amendment, a copy of which was previously executed by SAVOR and is attached to this Ordinance as **Exhibit I**.

SECTION 2. Funds generated by this Ordinance for concessions and sales will be deposited per the table below:
