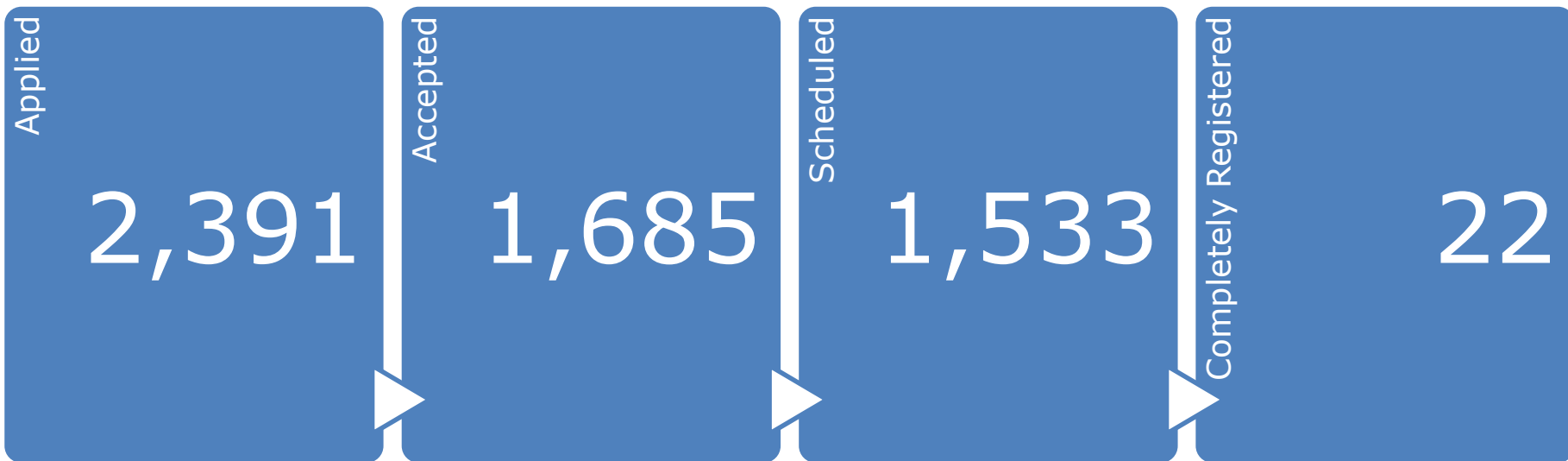

- Increase outreach and engagement on the city's cultural Eastside

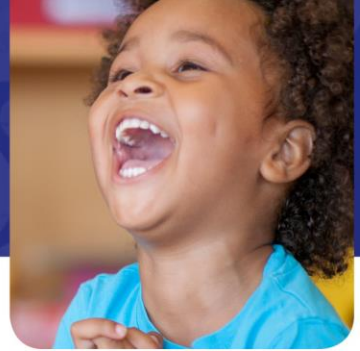

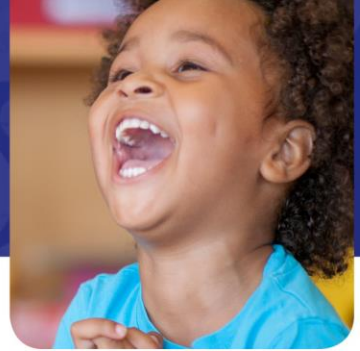

LEGISLATIVE UPDATE



LEGISLATIVE UPDATES



- HB 2039 voted out of the House last week
 - Reestablish EC – 3 certification
 - Sponsored by Representative Huberty, Humble
 - Currently no companion legislation in the Senate
- HB 1389 relating to class size caps for Pre-K: Still in House Public Education Committee
- HB 710 relating to free full day Pre-K: Still in House Public Education Committee

LEGISLATIVE UPDATES



- HB 2039 relating to EC-3rd grade certification: Voted out of Subcommittee on Teacher Quality and is now in the House Public Education Committee
- HB 357 relating to Pre-K eligibility to children of first responders: Voted out of House Public Education Committee and is on general calendar for 4/19
- HB 620 relating to first day of school: Still in House Public Education Committee
