Building-Related and Fire Codes Appeals and Advisory Board

The Building-related and Fire Codes Appeals and Advisory Board is comprised of seventeen members and seventeen alternate members all residing in the City of San Antonio that are appointed at-large by City Council. Nominations to City Council of both primary and alternate members for each category shall be made to the Secretary of the Appeals and Advisory Board by industry associations that are affiliated with nationally recognized organizations. Membership is by category and as follows:

One (1) member and (1) alternate shall be a structural engineer licensed or registered by the State of Texas as a professional engineer.

One (1) member and (1) alternate shall be a fire protection engineer licensed or registered by the State of Texas as a professional engineer.

One (1) member and (1) alternate shall be an electrical engineer licensed or registered by the State of Texas as a professional engineer.

One (1) member and (1) alternate shall be a plumbing engineer or a mechanical engineer licensed or registered by the State of Texas as a professional engineer.

One (1) member and (1) alternate shall be an architect licensed by the State of Texas.

Two (2) members and two (2) alternates shall be registered building contractors by the City of San Antonio.

Two (2) members and two (2) alternates shall be licensed by the State of Texas as a master electrician. Of these, one (1) member and one (1) alternate shall represent organized labor and one (1) member and one (1) alternate

Two (2) members and two (2) alternates shall be licensed by the State of Texas as an air conditioning and refrigeration contractor. Of these, one (1) member and one (1) alternate shall represent organized labor and one (1) member and one (1) alternate shall represent open shop.

Two (2) members and two (2) alternates shall be licensed by the State of Texas as a master plumber. Of these, one (1) member and one (1) alternate shall represent organized labor and one (1) member and one (1) alternate shall represent open shop.

One (1) member and (1) alternate shall be a commercial building contractor.

One (1) member and (1) alternate shall be a commercial building owner, manager, or their representative.

One (1) member and (1) alternate shall be a Residential Group R-2 multi-family building owner, manager, or their representative.

One (1) member and one (1) alternate shall be licensed by either the City of San Antonio or the State of Texas as a master sign electrician.

The Appeals and Advisory Board shall hear and decide appeals of orders, decision or determinations made by the Building Official or the Fire Chief relative to the applications and interpretations of Chapters 10, Chapter 11 and specific Articles in Chapter 28 of the City Code and shall provide advise to the Building Official or Fire Chief on code-related matters upon request.

Meetings are held on the second Tuesday of the months of January, April, July, and October, at 9:00 AM at the Cliff Morton Development and Business Services Center, Board Room, 1st Floor, 1901 S. Alamo. Meeting duration is approximately two hours. Special meetings are called during the building-related and fire codes adoption process and whenever formal appeals have been filed.


