**Section 1.** The City Council hereby directs the Development Services Department to initiate a change in the zoning district boundary of properties located at 2706 W. Southcross, to zoning districts compatible with the existing and surrounding land use.

**Section 2.** This Ordinance becomes effective immediately upon the receipt of eight affirmative votes, or in the event eight affirmative votes are not received, on the tenth day after passage.
