## AN ORDINANCE 2017 - 04 - 20 - 0260

**MEMORIAL** STREET NAME AUTHORIZING THE DESIGNATION OF "ARCHBISHOP PATRICK **FLORES** MEMORIAL WAY" FOR A PORTION OF W. WOODLAWN STREETS AVENUE BETWEEN THE CROSS OF N. ZARZAMORA AND BANDERA ROAD IN CITY COUNCIL **DISTRICT 7, SAN ANTONIO, TEXAS.**

WHEREAS, the Development Services Department staff (staff) received a City Council Request from Councilman Cris Medina (District 7) to grant a memorial designation to W. Woodlawn Avenue between the cross streets of N. Zarzamora and Bandera Road to honor the memory of Archbishop Patrick Flores, a leading local spiritual leader in our community who spread the message of hope and equality; and

**WHEREAS**, staff began implementing this request through the street naming /memorial designation process as required by Chapter 6 of the City Code; and

**WHEREAS**, staff forwarded this request to all City of San Antonio departments and outside agencies for review and no opposition has been identified; and

**WHEREAS**, staff conducted a technical review finding it to conform to City Code requirements for memorial designations; and

**WHEREAS**, staff properly posted and mailed notice of this request to attach the memorial designation to said street to abutting property owners, notice requirements for giving the memorial designation of the street have been satisfied in accordance with Chapter 6 of the City Code; and

WHEREAS, the Planning Commission held a public hearing on March 20, 2017 and recommended approval through a motion to support the memorial designation of "Archbishop Patrick Flores Memorial Way;" NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** W. Woodlawn Avenue located in City Council District 7 between N. Zarzamora and Bandera Road is hereby given the memorial designation of "Archbishop Patrick Flores Memorial Way." The location is more specifically depicted in Attachment 1. City staff is directed to provide appropriate signage to this effect.

**SECTION 2.** Funds generated by this ordinance will be deposited as per the table below:

**SECTION 4**. This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.
