Background



- **A community event in 36 cities across the U.S. and Canada**
 - **In San Antonio since 2010**
- **Youth learn about starting and running their own business**
- **Inspires hard work, saving, giving and fun**
- **In 2016:**
 - **73% of kids donated a portion of their earnings to charities**
 - **79% saved a portion of their earnings**

 - **Waive temporary food establishment fee and required inspection**
 - **Allow lemonade stands on private property with owner approval**
 - **Allow lemonade stands in City parks**

Fiscal Impact

- **Through this ordinance, the City will forgo the \$30.90 fee normally charged for every temporary food establishment.**
- **City resources including health inspectors and other City personnel will not be required to support this event negating the need for fees to offset costs.**

Recommendation

- **Staff recommends approval of an authorization for Metro Health to waive the temporary food establishment permit requirement, including fees and required inspections, for youth participating in Lemonade Day to be held on May 6, 2017.**
