AMENDING THE LAND USE PLAN CONTAINED IN THE KELLY/SOUH SAN PUEBLO COMMUNITY PLAN, A COMPONENT OF THE COMPREHENSIVE MASTER PLAN OF THE CITY, BY CHANGING THE USE OF APPROXIMATELY 0.7518 ACRES ON LOTS 1 THRU 10, BLOCK 15, NCB 8911, LOCATED AT 2706 W. SOUTHCROSS BOULEVARD, FROM NEIGHBORHOOD COMMERCIAL TO REGIONAL COMMERCIAL.

WHEREAS, the Kelly/South San Pueblo Community Plan was adopted on February 15, 2007 by City Council as a component of the City's Comprehensive Master Plan adopted May 29, 1997; and

WHEREAS, the Unified Development Code requires consistency between zoning and the Comprehensive Master Plan and Section 213.003 of the TEXAS LOCAL GOVERNMENT CODE allows amendment of the Comprehensive Master Plan following a public hearing and review by the Planning Commission; and

WHEREAS, a public hearing was held on April 26, 2017 by the Planning Commission allowing all interested citizens to be heard; and

WHEREAS, the San Antonio City Council has considered the effect of this amendment to the Comprehensive Master Plan of the City and has determined that it conforms to the approval criteria set forth in the Unified Development Code §35-420, Comprehensive, Neighborhood, Community, and Perimeter Plans; NOW THEREFORE;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The Kelly/South San Pueblo Community Plan, a component of the Comprehensive Master Plan of the City, is hereby amended by changing the use of approximately 0.7518 acres on Lots 1 thru 10, Block 15, NCB 8911, located at 2706 W. Southcross Boulevard, from Community Commercial to Regional Commercial. All portions of land mentioned are depicted in Attachment "I", attached hereto and incorporated herein for all purposes.

SECTION 2. This ordinance shall take effect the 14th day of May 2017.


