The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call and noted the following Councilmembers present:

- 1. The Invocation was delivered by Pastor Jimmy Robles, Last Chance Ministries, guest of Councilmember Shirley Gonzales, District 5.
- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.
- **3.** Approval of Minutes for the Regular City Council meetings of March 1-2, 2017.

Councilmember Warrick moved to approve the Minutes for the Regular City Council meetings of March 1-2, 2017. Councilmember Treviño seconded the motion. The motion prevailed by the following vote:

POINTS OF PERSONAL PRIVILEGE

Mayor Taylor recognized Dirk Wouters, Ambassador of Belgium to the United States. She stated that Mr. Wouters represented His Majesty The King of Belgians and Belgium's federal government in the United States. She noted that Mr. Wouters was in San Antonio most recently in December to accompany Her Royal Highness, Princess Astrid, and her distinguished trade mission delegation of almost 70 civic and business leaders. She added that she was pleased that Mr. Wouters had returned and welcomed him back to San Antonio. Mr. Wouters thanked Mayor Taylor for the recognition and stated that it was an honor to be back and reconnect with the City of San Antonio. He spoke of the great economic development partnerships that had been established thus far and stated that he looked forward to the future. The City Council welcomed Mr. Wouters to San Antonio.

Mayor Taylor recognized City Manager Sculley who reported that the San Antonio Fire Department had been awarded a Class 1 Public Protection Classification (PPC) Rating by the Insurance Services Office (ISO), the highest score a fire protection community can receive. Fire Chief Hood stated that San Antonio should be excited about the ISO Rating which was proof that the San Antonio Fire Department (SAFD) was among the nation's best. He thanked all of the Fire Personnel, City Council, and City Staff for their work and support of Public Safety. Phillip Bradley of the ISO commended the City of San Antonio Fire Department and presented them with a plaque. Jesse Williams of the State Fire Marshal's Office stated that he was proud to acknowledge SAFD's Class 1 Rating and presented Chief Hood with an Achievement Award. The City Council recognized SAFD for the Class 1 Rating and stated that they were pleased with the great accomplishment.

Councilmember Gonzales recognized Brackenridge High School Chef Jenny Placette and her team of students for winning the Paella Challenge hosted by Chef Johnny Hernandez. She noted that they would be travelling to the Culinary Institute of America Campus in Hyde Park, New York. Chef Placette thanked the City Council for the recognition and stated that they were excited to travel to New York and represent San Antonio. The City Council congratulated the Brackenridge High School Paella Challenge Team and wished them well on their travels.

Councilmember Gonzales welcomed the Children's Ballet of San Antonio (CBSA) and noted that they would be presenting tickets to the City Council to their next performance, Swan Lake. She recognized two Dancers, as well as Vanessa Bessler, Artistic Director and CBSA Founder, Tim Bessler, Chair of the CBSA Board, and Justice Luz Elena Chapa, Board Member. Ms. Bessler thanked the City Council for the recognition and spoke of their next performance. She noted that the students had participated in many competitions and received numerous awards. She mentioned the scholarships given to children to study at schools in the summer. Mrs. Chapa thanked the City Council for the recognition and stated that it was an honor to be present today. One of the Ballet Dancers spoke and stated that CBSA had provided her a foundation that would help her expand her career in different areas. The City Council thanked CBSA for the tickets and commended them on their many accomplishments.

Councilmember Saldaña highlighted the Port Authority of San Antonio (Item 11) and called upon Bill Mock, District 9 Board Member, and Roland Mower, CEO of the Port Authority. Mr. Mock stated that he was proud that they would be embarking on a new Tech Facility at the Port and thanked the City Council for their support. Mr. Mower also thanked the City Council for their support and stated that he was pleased with the many jobs and partnerships created. Councilmember Krier expressed his support and thanked Messrs. Mock and Mower for their work.

14. City Manager's Report

PRESERVATION MONTH IN MAY

Mrs. Sculley highlighted Preservation Month that will be observed during the month of May. She thanked everyone that participated by having their photos taken for the "Scout-SA" Historical Preservation Program. She noted that this vear part as of Preservation Month, the Office of Historic Preservation was launching Rehabarama. Rehabarama is a single-day event that will be held on May 13th in which volunteers, local contractors, students, and neighborhood leaders will join together to revitalize and restore a city block with aging housing stock in the Historic Denver Heights Neighborhood. She thanked Councilmember Warrick for his guidance on the project and mentioned that Guido Materials was the Title Sponsor and Frost Bank also made a significant contribution. She reported that the World Heritage Office has organized a VIA Bus Tour of the Missions along its Viva Missions Route on May 20th. She noted that the Amazing Preservation Race would be held on May 6th and the Amazing Preservation Race for kids was scheduled for May 20th at the San Antonio Zoo.

PEARSALL PARK – DESIGN EXCELLENCE AWARD

Mrs. Sculley reported that last month, the Texas Recreation and Park Society presented the City of San Antonio with a "Park Design Excellence Award" for Pearsall Park. She noted that Pearsall Park opened last summer though a \$9.8 Million investment from the 2012 Bond Program which transformed a former municipal landfill into an active play zone and signature park. She highlighted the features available to the public including a skate park, splash pad, fitness zone, and dog park. She recognized all for their great work on the park.

SA SPEAK UP

Mrs. Sculley provided an update on the SA Speak Up Program, the community input process for the Annual Budget. She stated that the SA Speak Up Community Engagement Campaign started two years ago and was led by the Government and Public Affairs Office. She noted that the SA Speak Up Team engages residents in English and Spanish through a wide range of media. Mrs. Laura Mayes shared some of this year's outreach strategies for SA Speak Up.
