**SUBJECT:** FY 2018 ABTPA Continuing and Modified Grant Applications

**Details:**

Please review the attached FY 2018 Texas Automobile Burglary Theft Prevention Authority Continuing and Modified grant applications. The San Antonio Police Department is seeking a Continuing grant funds not to exceed \$792, 617.00 and a Modified grant funds not to exceed \$871,378.00 from the Texas Automobile Burglary and Theft Prevention Authority (ABTPA) to combat vehicle crimes in the surrounding area. The Modified grant is an additional request above and beyond the grant we were awarded last year. In the Modified grant we are asking for 3 additional SAPD Detectives and 3 additional BCSO Detectives along with 2 additional civilian staff to include a Crime Analyst and an Administrative Assistant I who will take over duties at the front desk and relieve the detectives from this task. In addition we are asking for 3 covert vehicles for the new detectives which we plan to deploy in two man units. Upon approval and signature of the Chief, I will begin the RFCA process for both the Continuing and Modified grants. Our goal is to make the May 18th City Council meeting. We must submit approved grant applications, both Continuing and Modified, to ABTPA by June 2.

The grant applications are requesting a continuation of last year's grant, Continuing grant, and additional positions and equipment in the Modified grant. The ReACT grant project continues the Police Department's efforts at combating auto theft crimes. ReACT is a multi-jurisdictional unit composed of City and County elements. The San Antonio Police Department Vehicle Crimes Unit will work as part of the task force, and its General Fund budget will contribute to the in-kind portion of the grant.
