AN ORDINANCE

AN ORDINANCE AUTHORIZING A FUNDING AGREEMENT WITH THE SAISD FOUNDATION IN AN AMOUNT UP TO \$250,000.00 FROM THE CITY'S DEFERRED MAINTENANCE PROGRAM FUNDS TOWARDS THE FOX TECH CAMPUS FOR THE NEW CENTERS FOR APPLIED SCIENCE AND TECHNOLOGY TECH HIGH SCHOOL, LOCATED IN COUNCIL DISTRICT 1.

WHEREAS, the Centers for Applied Science and Technology High School (CAST Tech) on the Fox Tech campus, is a new career-themed high school focused on coding, cyber security, gaming and entrepreneurship that plans to work hand-in-hand with various industry partners like H-E-B, Tech Bloc, CodeUp, Geekdom, Rackspace, The Open Cloud Academy, USAA, Frost Bank, Firstmark Credit Union, University Health System and UTSA, to prepare students for careers in technology and business; and

WHEREAS, campus renovations are presently underway on the Fox Tech campus and the City's contribution in the amount of \$250,000.00 will be used towards completion and opening by August 2017; and

WHEREAS, in exchange for the City's contribution, the City and groups the City identifies, such as Workforce Solutions, Café College and Project Quest, will be given access to the CAST computer lab one Saturday a month excluding July and December for a period of three years; and

WHEREAS, the general public will benefit from the provision of access to computer labs and other facilities for children, students and adults for computer literacy training, internet and computer access to support educational courses and college applications and submittals, as well as supporting workforce development and employment opportunities; and

WHEREAS, the City Council finds that the improvements and renovation of designated San Antonio Independent School District property that will then be made available to the citizens of San Antonio is a public purpose that will benefit the economic and workforce development of the City of San Antonio; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Director of Human Services (DHS) or her designee, is authorized to execute an agreement with the SAISD Foundation for an amount up to \$250,000.00 for improvement and renovations to the CAST Tech High School, in exchange for access to computer labs and other facilities for a period beginning upon execution and ending on June 30, 2020. A copy of the agreement in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I**.

SECTION 2. FINANCIAL LANGUAGE PENDING

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
