AN ORDINANCE

AUTHORIZING AN AGREEMENT WITH THE SOUTHWEST TEXAS REGIONAL ADVISORY COUNCIL (STRAC) TO PROVIDE FUNDING TO STRAC IN AN AMOUNT NOT TO EXCEED \$7,500.00 IN SUPPORT OF A MULTIAGENCY FUNDED LICENSE FOR EVERBRIDGE SOFTWARE RELATED TO PUBLIC HEALTH EMERGENCY PREPAREDNESS ACTIVITIES FOR BEXAR COUNTY FOR A PERIOD FROM JULY 1, 2017 THROUGH JUNE 30, 2018.

WHEREAS, in FY 2015 in response to decreasing Public Health Emergency Preparedness (PHEP) and Hospital Planning and Preparedness funds, the San Antonio Metropolitan Health District (Metro Health) in conjunction with the Southwest Texas Regional Advisory Council (STRAC), the Texas Department of State Health Services (DSHS) Region 8 and the many hospital facilities throughout DSHS Region 8 initiated a multi-agency cost sharing plan to enhance efficiencies that would maintained medical response systems; and

WHEREAS, Metro Health is requesting City Council authorization of an agreement with STRAC to provide funding in an amount not to exceed \$7,500.00 in support of a multiagency funded license for the EverBridge License used to notify medical staff in an emergency event and maintenance of services related to public health emergency preparedness and other medical response systems; and

WHEREAS, this will allow Metro Health's PHEP program to comply with grant deliverables with greater cost efficiencies and enhance medical response capabilities throughout DSHS Region 8; NOW THEREFORE:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or his designee is authorized to execute an agreement with the Southwest Texas Regional Advisory Council (STRAC) to provide funding to STRAC in an amount not to exceed \$7,500.00 in support of a multiagency funded license for EverBridge software related to public health emergency preparedness activities for Bexar County for a period from July 1, 2017 through June 30, 2018. A copy of said agreement in substantially final form is attached hereto and incorporated herein for all purposes as **Attachment I.**

SECTION 2. Funds will be appropriated upon creation of the fund "PHEP Hazards 2018". Payment is authorized to STRAC on or after July 1, 2017 and upon issuance of a Purchase Order.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
