

AN ORDINANCE 2017-05-18-0346

**SCHEDULING SPECIAL AND RESCHEDULING CITY COUNCIL
MEETINGS IN JUNE, JULY AND AUGUST, 2017.**

WHEREAS, the May 6, 2017 general election resulted in the need for a June 10, 2017 runoff election in several council districts, which must then be canvassed; and

WHEREAS, due to the need for City staff and the City Council to meet to set goals and plan the FY 2018 budget, it is necessary to schedule special City Council meetings, and to reschedule all July City Council and Council Committee meetings; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. Special City Council Meetings are scheduled as follows:

SECTION 2. The June 28-29 and all July 2017 City Council Meetings are rescheduled to the next available date in August 2017 as follows:




SECTION 5. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise it is effective on the tenth day after passage.


