Partner with multiple agencies to provide free spay/neuter surgeries for owned pets



Surgeries to include medical evaluation and post operative evaluation


#### **Surgeries Provided to Residents Free of Charge**

- Registered Microchips and Rabies Vaccinations at Cost if necessary
- Surgeries to include medical evaluation and post operative evaluation

**City reimburses provider \$75 per surgery** 



## **Project Scope – Respondent's Responsibilities**



- Provide 11,933 Free Spay-Neuter Surgeries annually
- Provide Low-Cost Rabies Vaccinations and Registered Microchips
- Provide Humane and Proper Care of Animals
- Maintain a 99% Success Rate
