The City Council convened in a Regular City Council Meeting. City Clerk Leticia Vacek took the Roll Call with the following Councilmembers present:

- 1. The Invocation was delivered by Pastor Adam Knight, Coker United Methodist Church, guest of Councilmember Joe Krier, District 9.
- 2. Mayor Taylor led the Pledge of Allegiance to the Flag of the United States of America.

POINT OF PERSONAL PRIVILEGE

Councilmember Viagran recognized the Industrial District and related matters with Marmaxx Operating Corporation (Items 25A, 25B, and 25C). Rene Dominguez stated that the city was creating a non-annexation agreement with Marmaxx to include establishment of their distribution center. He noted that they would create 1,000 jobs and donate 300 acres of wetland to create a natural buffer between their site and Mission Espada. Mark Walker, VP of Real Estate for Marmaxx, addressed the City Council and stated that they were excited to partner with the City of San Antonio. Councilmember Viagran thanked the San Antonio River Authority and Texas A&M University who for their partnership with Marmaxx. Mayor Taylor thanked everyone for their work on the project.

Councilmember Treviño highlighted the item and requested a brief presentation. Jeff Coyle stated that in March 2017, the City Council approved a professional services contract to provide written Spanish translations of City Council A and B Session agendas, memos, and selected news releases. He mentioned that Spanish language interpreters were currently on-site at all City Council A and B Sessions, as well as Development Services boards and commissions. He outlined the Request for Proposal (RFP) process and reported that the Committee selected SeproTec Multilingual Solutions, LLC. He stated that SeproTec was one of the world's largest translation and interpreting companies with services in over 500 language combinations. Councilmember Treviño thanked everyone for their work and stated that this was a very important issue to ensure the city is being as inclusive as possible.

Councilmember Treviño moved to adopt the ordinance for Item 4. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Councilmember Treviño stated that he pulled the item to highlight innovative approaches to important projects in the city. Razi Hosseini spoke of the drainage improvements that would be made and noted that they were confident that they would reduce or eliminate flooding in the area.

Councilmember Treviño moved to adopt the ordinance for Item 10. Councilmember Warrick seconded the motion. The motion prevailed by the following vote:

Councilmember Viagran requested a brief presentation. Razi Hosseini stated that Item 12A would authorize the execution of a funding agreement to oversee the street design of the South New Braunfels extension from Lyster Road to Loop 410 South. He noted that it would include 4,700 linear feet of secondary arterial street, a new signalized intersection, storm drains, storm water detention systems, and a 10-foot wide multi-use path. He mentioned that Item 12B would amend the funding agreement with Brooks Development Authority to design and construct all four phases of the linear park. He indicated that 43 acres of linear park would be constructed to include 3 miles of lighted hike and bike paths, 3 pavilions, and 9 acres of recreational areas. He noted that the South New Braunfels design would be completed by December 2017 and the linear park would be completed by February 2018. Councilmember Viagran thanked the City Council for their support and recognized Leo Gomez, President and CEO of Brooks City Base. Mr. Gomez highlighted the project and stated that he appreciated the support of the City Council.

Councilmember Krier expressed his support for the projects and asked of the University of the Incarnate Word Medical School. Mr. Gomez replied that the first student body had been selected and their classes would begin in August. Mayor Taylor stated that she appreciated Mr. Gomez's dedication and vision and was pleased with the difference that would be made in the lives of families on the south side.

Councilmember Viagran moved to adopt the ordinances for Items 12A and 12B. Councilmember Lopez seconded the motion. The motion prevailed by the following vote:

Michael Shannon presented a power point noting that a Council Consideration Request (CCR) had been sponsored by Councilmember Treviño requesting that weekly reports be provide registered to neighborhood associations within a Neighborhood Conservation District (NCD). He noted that the reports would provide information regarding preliminary plan review meetings and permit applications. He reported that they had created an online weekly report that would be provided to the 9 NCDs and presented a sample report. He added that they would amend the Unified Development Code and that all reports would be available on the Development Services Department Website. Councilmember Treviño thanked everyone for their work and spoke of the importance of dialogue with NCDs.

Councilmember Lopez requested a brief presentation. Shahrzad Dowlatshahi stated that staff was recommending authorization to enter into a Sister City Agreement with the City of Darmstadt, Germany. She provided a city profile of Darmstadt noting that it was known as the "City of Science." She indicated that San Antonio and Darmstadt have mutual promotion of economic cooperation, bilateral trade, and cultural, scientific, and educational exchanges in IT/Cybersecurity, Heritage Tourism, Aerospace, Biomedical/Health Care, and Renewable Energy. She added that UTSA and the Technical University of Darmstadt hope to sign a cooperative Memorandum of Understanding during the October 2017 trade mission to Darmstadt. Councilmember Lopez stated that this was a very important agreement and spoke of his personal experiences visiting that region of Germany when he was in the Army.

Councilmember Viagran stated that she was honored to have visited Darmstadt two years ago and highlighted the economic investments between the two cities. She expressed her support for the Sister City Agreement which was an incredible opportunity. Councilmember Nirenberg thanked staff for their work in Germany over the past few years. He recognized the 60th Anniversary of Sister Cities International last year and added that this partnership was very important for the City of San Antonio. Mayor Taylor stated that she was pleased to be at this point and that this partnership was in alignment with the vision of San Antonio being a globally competitive city. She added that these types of relationships help promote awareness of our economy and culture on a global scale. She thanked Councilmember Lopez for being a great proponent for the expansion of international relationships.

PUBLIC WORKS WEEK

Mrs. Sculley reported that National Public Works Week was being celebrated this week to appreciation for the many individuals throughout the country show that maintain infrastructure and provide services that improve quality of life. She noted that each year since 1960; the American Public Works Association observes National Public Works Week to help bring awareness, educate, and extend much deserved recognition of the professionals who serve the public. She mentioned that the City of San Antonio Transportation and Capital Improvements (TCI) Department consists of 860 employees and manages the city's streets, storm water, and traffic operations. She thanked TCI for their work.

ZIKA PREPAREDNESS

Dr. Colleen Bridger presented an update on Metro Health's preparedness efforts to combat the Zika Virus. She highlighted transmission, infection, and symptoms of the virus and outlined prevention techniques and added that the Metro Health website was a resource for the community.

Jeff Coyle provided a status of the city's priorities in the State Legislative.
