

AN ORDINANCE

AUTHORIZING THE SUBMISSION OF A GRANT APPLICATION AND ACCEPTANCE OF FUNDS IN AN AMOUNT UP TO \$8,089,799.00, WITH THE CITY'S SHARE OF \$2,861,351.00, FROM THE FEDERAL AVIATION ADMINISTRATION FOR AIRPORT IMPROVEMENT PROGRAM PROJECTS AT SAN ANTONIO INTERNATIONAL AIRPORT, AND AUTHORIZING EXECUTION OF GRANT DOCUMENTS.

WHEREAS, the FAA through the Airport Improvement Program (AIP) has designated the City to receive an FAA AIP Grant in the amount not to exceed \$10,951,150.00 to fund two AIP-eligible projects: Runway 12R Rehabilitation Phase 5 and Perimeter Road Reconstruction; and

WHEREAS, FAA funding for the AIP Grant would be \$8,089,799.00.00 with the City providing \$2,861,351.00 from Airport Funds; and

WHEREAS, it is now necessary to authorize the submission of the grant application, acceptance of the grant, and execution of the grant acceptance documents associated with the FAA AIP grant for the Runway 12R Rehabilitation - Taxiway R Rehabilitation - Package 5 and Perimeter Road Reconstruction projects; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee, or the Aviation Director, is hereby authorized to submit a grant application and accept, upon award, an amount up to \$8,089,799.00 from the Federal Aviation Administration for improvements associated with the Runway 12R Rehabilitation and Perimeter Road Reconstruction projects. The City will provide a cash match of \$2,861,351.00 from Airport Funds to provide a total project cost of \$10,951,150.00. The City Manager, her designee, or the Aviation Director, is further authorized to execute such documents as are necessary to accept these FAA AIP grant.

SECTION 2. Upon award of the grant, the amount of \$575,272.00 will be appropriated in SAP Fund 2205833xxA, Perimeter Road Reconstruction, and the budget shall be revised by increasing SAP Internal Order # 133000000xxA, SAP GL account 4501000 - Grants Revenue.

SECTION 3. The amount of \$575,272.00 is appropriated in SAP Fund 2205833xxA, Perimeter Road Reconstruction, SAP Internal Order # 133000000xxA, SAP GL account 6102100 - Interfund Transfer Out. The amount of \$575,272.00 is authorized to be transferred to SAP Fund 51099000, Airport Capital Projects.

SECTION 4. The budget in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00024, Perimeter Road Reconstruction, shall be revised by increasing SAP WBS

SECTION 11. The budget in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00178, Runway 12R Rehabilitation, shall be revised by decreasing SAP WBS element 33-00178-90-11-01 entitled Transfer from AV-00006-01-02-68, SAP GL account 6101100, by the amount of \$513,765.00.



SECTION 16. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 17. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
