AMENDING THE FISCAL YEAR 2017 CAPITAL IMPROVEMENTS PROGRAM AND APPROPRIATING ONE MILLION DOLLARS THREE HUNDRED AND NINETY-THREE THOUSAND, FIVE HUNDRED EIGHTY-ONE DOLLARS AND NO CENTS (\$1,393,581.00) AVAILABLE FROM INNER CITY TAX INCREMENT REINVESTMENT ZONE NUMBER REINVESTMENT MIDTOWN TAX INCREMENT NUMBER THIRTY-ONE, THE CITY'S PARKING FUND AND THE SAN ANTONIO RIVER AUTHORITY WATERSHED WISE REBATE PROGRAM. FOR THE DESIGN AND CONSTRUCTION OF THE BROADWAY UNDERPASS IMPROVEMENTS PROJECT, LOCATED AT THE TXDOT RIGHT OF WAY **ALONG BROADWAY** STREET UNDER THE INTERCHANGE OF INTERSTATE HIGHWAY 35 AND US HIGHWAY 281.

WHEREAS, in July 2013, the Transportation and Capital Improvements Department received a grant from the TxDOT to beautify five underpass sites around the City and the TxDOT right of way along Broadway Street under Interstate Highway 35 and US Highway 281 was selected as one of the beautification project sites; and

WHEREAS, given the high demand for public parking in the area which is anticipated to grow substantially as a result of the Broadway Corridor Improvements Project and other neighborhood revitalization development efforts, City staff coordinated with area stakeholders, agency partners and others to plan, design, and fund a public parking surface lot; and

WHEREAS, the proposed public parking surface lot is within walking distance of popular City destinations such as the Pearl, Museum Reach of the San Antonio River, San Antonio Museum of Art, Maverick Park, restaurants and music venues - all of which have very limited public parking options; and

WHEREAS, the six-acre Central Zone project site, includes approximately 180 parking spaces, ample green space with landscaping, and trees, and will include a walking trail to facilitate connectivity between the east and west sides of Broadway; and

WHEREAS, the City is partnering with the San Antonio River Authority ("SARA") to include three Low Impact Development ("LID") features to showcase best practices for slowing and treating storm water runoff before leaving the site; and

WHEREAS, the estimated cost of the Broad Underpass Improvements Project (the "Project") is approximately One Million, Three Hundred Ninety-Three Thousand, Five-Hundred and Eighty-One Dollars and No Cents (\$1,393,581.00); and

WHEREAS, funding for the Project has been identified from four sources, comprised of One Million Dollars and No Cents (\$1,000,000.00) in reimbursable tax increment from the Inner City

Tax Increment Reinvestment Zone #11, Two Hundred Fifty Thousand Dollars and No Cents (\$250,000.00) in reimbursable tax increment from the Midtown Tax Increment Reinvestment Zone #31, Two Hundred Fifty Thousand Dollars and No Cents (\$250,000.00) from the City's Parking Fund, and One Hundred Thousand Dollars and No Cents (\$100,000.00) in reimbursable funds from the SARA Watershed Rebate Program; and

WHEREAS, the City of San Antonio's Parking Division of the Center City Development and Operations Departments will manage and maintain the parking lot, and the Transportation and Capital Improvements Department will maintain the remainder of the site; and

WHEREAS, SARA will manage the Project through the design and construction phase and provide maintenance of LID features for the first three years after construction in exchange for a portion of the parking revenues to cover their costs; and

WHEREAS, construction of the Project will commence in September 2017 and be completed in January 2018; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:
