AN ORDINANCE

RATIFYING THE ACCEPTANCE OF FUNDS AND THE EXECUTION OF GRANT DOCUMENTS FOR THE CHOICES CHILDHOOD OBESITY PREVENTION GRANT WITH HARVARD UNIVERSITY SCHOOL OF PUBLIC HEALTH IN THE AMOUNT OF \$50,000.00 FOR 12 MONTHS BEGINNING JULY 1, 2017, AND AUTHORIZING A PERSONNEL COMPLEMENT.

WHEREAS, childhood obesity is a complex health issue affecting San Antonio/Bexar County across socioeconomic and demographic boundaries; and

WHEREAS, the causes are similar to those of adult obesity, including dietary patterns, physical inactivity, health disparities, educational attainment, food marketing and promotion, and intergenerational poverty; and

WHEREAS, higher rates of childhood obesity in our central urban core are interconnected to the socioeconomic status and environmental conditions of these neighborhoods;

WHEREAS, the Harvard University School of Public Health's CHOICES Program which supports the prevention of childhood obesity, is a twelve month award of \$50,000.00 beginning July 1, 2017 through June 30, 2018; **NOW THEREFORE:**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The acceptance of funds from the Harvard University School of Public Health in the amount of \$50,000.00 for the Choices Childhood Obesity Prevention grant to include the execution of a Memorandum of Understanding attached hereto and incorporated herein for all purposes as **Attachment I** is hereby ratified.

SECTION 2. The City Manager or her designee or the Director of the San Antonio Metropolitan Health District or her designee is authorized to initiate, negotiate and execute any and all necessary documents to effectuate the acceptance of the funds referenced in Section 1 above.

SECTION 3. Upon award, a new fund and internal order will be created for use in the accounting for the fiscal transaction in the acceptance of this grant and the amounts listed above totaling a sum not to exceed \$50,000.00 will be appropriated in said fund. The proposed budget attached hereto and incorporated herein for all purposes as **Attachment II** is approved. A formal final budget which will include Internal Order numbers and General Ledger numbers will be submitted by the department upon award.

SECTION 4. The personnel complement of 25% of one position which is attached hereto and incorporated herein as **Attachment II** is approved.

SECTION 5. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 6. This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
