FY2018 Congressional Budget Timeline



- March 16, White House released its "skinny" Budget Blueprint.
- May 23, White House released full budget.
- House Appropriations Committee has passed the 12 bills.
- Senate Appropriations Committee has passed 6 bills.
- July 27, Full House approved the Make America Secure Appropriations Act.
- Congress must pass the FY18 Budget before the October 1
 deadline.
