AN ORDINANCE

AUTHORIZING CONTRACTS WITH THE AKANA GROUP INC., C&M GOLF & GROUNDS EQUIPMENT, HOLT TEXAS, LTD., SAGELINE INC., AND TUTTLE MOTOR COMPANY TO PROVIDE CITY DEPARTMENTS WITH TRACTORS AND LANDSCAPING EQUIPMENT FOR AN ESTIMATED TOTAL COST OF \$1,594,054.18 OVER A TWO YEAR PERIOD, FUNDED FROM THE EQUIPMENT RENEWAL AND REPLACEMENT FUND AND STORM WATER FUND.

WHEREAS, bids were submitted to provide various departments of the City of San Antonio with tractors and landscaping equipment for a various mowing, vegetation projects, and park maintenance projects throughout the City; and

WHEREAS, the bids submitted by Holt Texas, LTD. (Items 1, 5, and 6), H&V Equipment (Item 1), The Akana Group Inc. (Item 4), Ag-Pro Texas (Items 5 and 6), and Ewald Kubota (Item 6), failed to meet the City's specifications and/or requirements; and

WHEREAS, the lowest responsive bids were submitted by Tuttle Motor Company for items 1 and 5, Holt Texas, LTD. for item 2, C&M Golf & Grounds Equipment for items 4 and 10, The Akana Group Inc. for item 6, and Sageline Inc. for items 7-9; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The low, responsive bids from Tuttle Motor Company (Items 1 and 5), Holt Texas, LTD. (Item 2), C&M Golf & Grounds Equipment (Items 4 and 10), The Akana Group Inc. (Item 6), and Sageline Inc. (Items 7-9) to provide the City of San Antonio with tractors and landscaping equipment for an estimated total cost of \$1,594,054.18 over a two year period are hereby accepted, subject to and contingent upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. It has been found and declared that the bids from Holt Texas, LTD. (Items 1, 5, and 6), H&V Equipment (Item 1), The Akana Group Inc. (Item 4), Ag-Pro Texas (Items 5 and 6), and Ewald Kubota (Item 6) failed to meet the City's specifications and/or requirements.

SECTION 3. Funding for this ordinance in the amount up to \$397,778.02 is available as part of the Fiscal Year 2017 budget per the table below:

SECTION 4. Payment not to exceed the budgeted amount is authorized to The Akana Group, Inc., C&M Golf & Grounds Equipment, Holt Texas, LTD, Sageline, Inc., and Tuttle Motor Company and should be encumbered with a purchase order.

SECTION 5. Additional funding for this ordinance in an amount up to \$1,196,276.16 will be encumbered upon issuance of purchase orders, and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2018 budget and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

SECTION 6. The financial allocations in this ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this ordinance.

SECTION 7. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
