## AN ORDINANCE

AUTHORIZING **INTERLOCAL AGREEMENTS** WITH THE UNIVERSITY OF TEXAS HEALTH SCIENCE CENTER AT SAN ANTONIO TO PROVIDE THE SAN ANTONIO FIRE DEPARTMENT WITH CONTRACTS FOR A PERIOD BEGINNING OCTOBER 1, 2017 AND ENDING SEPTEMBER 30, 2020, WITH TWO EXTENSIONS OF ONE YEAR EACH FOREMERGENCY MEDICAL TECHNICIAN TRAINING AND EMERGENCY MEDICAL SERVICES (EMS) SYSTEM OVERSIGHT FOR AN ESTIMATED COST FOR THE FIRST YEAR OF \$1,840,730, AND EMS MEDICAL DIRECTION SERVICES FOR AN ESTIMATED COST FOR THE FIRST YEAR OF \$1,298,509, AND AMENDING THE PRIOR INTERLOCAL AGREEMENTS BETWEEN THE PARTIES TO PROVIDE FOR CERTAIN PAYMENTS OUT OF **RESIDUAL FUNDS.**

WHEREAS, it is necessary to contract with an entity to provide the San Antonio Fire Department with emergency medical technician (EMT) training and emergency medical services (EMS) system oversight ("Control and Training Agreement"); and

WHEREAS, it is necessary to contract with an entity to provide the San Antonio Fire Department with emergency medical services (EMS) medical direction ("Medical Direction Agreement"); and

WHEREAS, the University of Texas Health Science Center at San Antonio (UTHSCSA) is willing and able to provide the required services; and

**WHEREAS**, the contracts will be for a period beginning October 1, 2017 and ending September 30, 2020, and provides for two one-year extensions; and

**WHEREAS**, the Control and Training Agreement shall be for an estimated cost of \$5,697,223.00 for the initial term; and

**WHEREAS,** the Medical Direction Agreement shall be for an amount not to exceed \$3,973,624.00 for the initial term; and

**WHEREAS,** it has become necessary to amend the prior Control and Training Agreement and the prior Medical Direction Agreement, approved by ordinance numbers 2015-11-12-0951 and 2015-11-12-0952, to provide for payment of certain invoices out of residual funds that accumulated during the course of those agreements; and

**WHEREAS**, the Parties shall mutually agree on the cost of the contract for each renewal period; **NOW THEREFORE**:

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager and her designee are hereby authorized to execute interlocal agreements with the UTHSCSA to provide the San Antonio Fire Department with EMT training and EMS system oversight and medical direction, and to execute an amendment to the prior agreements for these services with UTHSCSA. The interlocal agreements and amendment are attached hereto in substantially final form as **Exhibits I, II and III**.

**SECTION 2.** [Fiscal ordinance language to be provided in final draft.]

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts, as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
