These proposed contracts will provide general repairs to the City’s Class 4 through Class 8 trucks, including multiple makes and models of refuse trucks, fifth wheel tractor/trailers, grappler trucks, roll-off trucks, aerial lift trucks, street sweepers and pothole patch trucks.
