AN ORDINANCE 2017 - 08 - 17 - 0563

AUTHORIZING A TASK ORDER TO A JOB ORDER CONTRACT WITH ALPHA BUILDING CORPORATION IN AN AMOUNT NOT TO EXCEED \$153,307.54 FOR THE INSTALLATION OF THE CURTISS JN-4 (JENNY) AIRCRAFT AT SAN ANTONIO INTERNATIONAL AIRPORT.

WHEREAS, the San Antonio Airport System in coordination with the Witte Museum, will install a ceiling mounted display of a Curtiss JN-4 "Jenny" vintage aircraft in the ticketing hall of the San Antonio International Airport Terminal B Departures Level; and

WHEREAS, Ordinance No. 2015-01-15-0013 authorized a Job Order Contract (JOC) with Alpha Building Corporation to provide on-call construction, renovation and maintenance services for City buildings and facilities, and

WHEREAS, this Ordinance authorizes a Task Order to the JOC with Alpha Building Corporation in an amount not to exceed \$153,307.54 for the installation of the Jenny aircraft and construction of a display with background and history on the Jenny; NOW THEREFORE,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The City Manager or her designee is authorized to issue a Task Order to the Job Order Contract with Alpha Building Corporation in an amount not to exceed \$153,307.54 for the installation of the Jenny and construction of an information display at the San Antonio International Airport.

SECTION 2. Payment in the amount not to exceed \$153,307.54 in SAP Fund 51099000, Airport Capital Projects, SAP Project Definition 33-00248, Airplane Display, is authorized to be encumbered and made payable to Alpha Building Corporation, for the installation of the Curtiss JN-4 "Jenny" aircraft at the San Antonio International Airport.

SECTION 3. The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

SECTION 4. This Ordinance shall be effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
