## **FY 2018 Outputs:**

- Complete Vulnerable Communities Assessment & Toolkit
- Complete Infrastructure Affordability Study
- Complete analysis and finalize recommendations related to SAWS impact fees for affordable housing
- Finalize recommendations on a relocation assistance policy
- Assist in the planning and implementation of the annual Housing Summit

## **Description of Work Plan Items:**

- Vulnerable Communities Assessment & Toolkit this pair of consultant-led studies will
  help identify residents and neighborhoods at risk of losing affordable housing, due
  either to prolonged disinvestment or rapid redevelopment pressures, as well as develop
  a "toolkit" of policy responses to mitigate resident and neighborhood vulnerability. The
  first phase (Assessment) will be completed by November 2017; the second phase
  (Toolkit) will be completed in fall 2018.
- Infrastructure Affordability Study this consultant-led study will identify development patterns and housing types that promote long-term affordability related to the costs of providing municipal infrastructure and services. The study will be completed by November 2017.
- Assessment of SAWS Impact Fees the Housing Commission has been working with staff to identify the impact of SAWS development fees on the provision of affordable housing in San Antonio. Staff anticipates requesting that SAWS allocate additional resources toward fee waivers exclusively for the development of affordable housing. This work is expected to be completed by November 2017.
- Relocation Assistance Policy a draft policy is currently being developed that will
  address displacement concerns related to the redevelopment of existing housing units.
  The Housing Commission is expected to review the draft and provide a formal
  recommendation to City Council by the second quarter of FY 2018.
