## AN ORDINANCE 2017 - 09 - 21 - 0691

AUTHORIZING THE ACCEPTANCE OF A FY 2017 HOUSING COUNSELING GRANT IN THE AMOUNT OF \$24,661.00 FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE PERIOD OCTOBER 1, 2016 TO MARCH 31, 2018; AND APPROVING A BUDGET.

WHEREAS, the Department of Human Services (DHS) Fair Housing/Housing Counseling Program (FHHC) has provided housing counseling services to homeowners as a U.S. Department of Housing and Urban Development (HUD) Certified Housing Counseling agency since 1979; including foreclosure prevention counseling; and

**WHEREAS,** FHHC supports the delivery of a wide variety of housing counseling services to homebuyers, homeowners, low to moderate income renters, and those in danger of or experiencing homelessness, regardless of income; and

WHEREAS, Ordinance No. 2016-03-31-0227 authorized DHS to apply for HUD housing counseling grant funds available for FY 2016 and FY 2017, and authorized acceptance of funds for FY 2016; and

**WHEREAS**, on July 14, 2017, DHS received notice from HUD that continued funding for FY 2017 is available through March 31, 2018; **NOW THEREFORE**:

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** The City Manager or her designee, or the Director of the Department of Human Services (DHS) or her designee, is authorized to accept the FY 2017 Housing Counseling Grant in the amount of \$24,661.00 from the U.S. Department of Housing and Urban Development (HUD) for the period October 1, 2016 to March 31, 2018, and to execute any and all documents necessary to effectuate acceptance of funds. A copy of the original grant application is on file with DHS.

**SECTION 2**. The City Manager or her designee, or the Director of DHS or her designee, is further authorized to execute amendments pertaining to this award in the following instances: a) line item budget revisions authorized by the granting agency; b) no cost extensions; and c) the provision of supplemental grant funds by the funding agency in a cumulative amount up to 20% of the total amount initially awarded to the grant.

**SECTION 3.** Upon acceptance of this award, a new fund and internal order number will be created, upon which the award amount will be appropriated from HUD. The budget, which is attached hereto and incorporated herein for all purposes as **Attachment I**, is approved and adopted for entry in the City books.

**SECTION 4.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 5.** This Ordinance is effective immediately upon the receipt of eight affirmative votes; otherwise, it is effective ten days after passage.
