**A RESOLUTION RECOMMENDING APPROVAL OF THE STREET
MEMORIAL DESIGNATION OF “VICTORIA ROBLES MEMORIAL
WAY” FOR A PORTION OF BRADY BLVD. BETWEEN THE CROSS
STREETS OF S. ZARZAMORA AND S. CALAVERAS IN THE CITY
COUNCIL DISTRICT 5, SAN ANTONIO, TEXAS.**

WHEREAS, the Development Services Department staff (staff) received a City Council Consideration Request from Councilmember Shirley Gonzales (District 5) to grant a memorial designation to a portion of Brady Blvd. between the cross streets of S. Zarzamora and S. Calaveras; and

WHEREAS, to honor the memory of Victoria Robles, a local spiritual leader in her community; and

WHEREAS, Chapter 6 of the City Code of San Antonio, Texas, requires memorial designation requests to be considered by the Planning Commission of the City of San Antonio and its recommendation forwarded to the City Council; and

WHEREAS, the City of San Antonio Development Services Department in accordance with Chapter 6 of the City Code of San Antonio, Texas, notified all of the five (5) abutting property owners of real property along the segment of the street proposed for the memorial designation; however, no properties will be required to change their address; and

WHEREAS, the Planning Commission of the City of San Antonio held a public hearing on November 13, 2017, where they reviewed the request of the proposed memorial designation;

NOW, THEREFORE, BE IT RESOLVED BY THE PLANNING COMMISSION OF THE CITY OF SAN ANTONIO THAT:

SECTION 1: The Planning Commission of the City of San Antonio recommends **APPROVAL** of the proposed memorial designation of “Victoria Robles Memorial Way”, for a portion of Brady Blvd. between S. Zarzamora and S. Calaveras in City Council District 5 (**Exhibit “A”**).


