**AN ORDINANCE**

**AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH  
WASTE MANAGEMENT OF TEXAS, INC., TO EXTEND THE  
CONTRACT FOR AN ADDITIONAL 60 DAYS FOR AN ESTIMATED  
AMOUNT OF \$146,000.00, FUNDED FROM THE FY 2018 OPERATING  
BUDGET**

**WHEREAS**, on October 18, 2012, the City Council approved Ordinance 2012-10-18-0817, which selected Waste Management of Texas, Inc., to provide municipal commercial garbage collection, disposal and recycling services, and authorized the execution of a contract pursuant to the City's Request for Proposal for "Municipal Commercial Garbage Collection, Disposal and Recycling Services for the City of San Antonio" (RFP 6100001491) issued by the City on July 26, 2012; and

**WHEREAS**, The term of the contract was for a period of two years to November 30, 2014 with two additional one year renewal terms, and the City exercised both of the renewal options and the contract was to terminate on November 30, 2016; and

**WHEREAS**, Amendment One to the contract was approved by Ordinance 2016-11-10-0888 and extended the contract for an additional one year, with a new termination date of November 30, 2017; and

**WHEREAS**, in order to provide continued services to the City facilities during the transition period, the City and Waste Management have agreed to extend the current contract, under the same terms and conditions, as amended, for an additional 60 day period, with a new termination date of January 31, 2018; and

**WHEREAS**, this Ordinance authorizes and approves Amendment Two to the municipal commercial garbage collection, disposal and recycling services contract with Waste Management of Texas, Inc., to extend the current contract for an additional 60 days, and increase the contract by \$146,000.00, to provide continued service to City facilities, under the same terms and conditions; **NOW THEREFORE**,

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:**

**SECTION 1.** The current contract for municipal commercial garbage collection, disposal and recycling services with Waste Management of Texas, Inc., is amended to extend the term of the contract by an additional 60 days, from November 30, 2017 to a new termination date of January 31, 2018, under the same terms and conditions, and increase the contract by \$146,000.00. A copy of the contract Amendment is attached as **EXHIBIT "A"** and made a part hereof and incorporated herein for all purposes.

**SECTION 2.** This ordinance amends the current contract with Waste Management, Inc. to increase the contract by \$146,000.00. The amount will be encumbered upon issuance of purchase orders, and payment is authorized to Waste Management, Inc. All expenditures will be in accordance with the Fiscal Year 2018 and subsequent budgets that fall within the term period of this contract approved by City Council.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4.** This Ordinance shall become effective immediately upon passage by eight (8) or more affirmative votes or, if passed by fewer than eight (8) affirmative votes, shall be effective ten (10) days after passage.
