## AN ORDINANCE 2017-12-07-0938

AUTHORIZING THE MEMORIAL STREET NAME DESIGNATION OF "VICTORIA ROBLES MEMORIAL WAY" FOR A PORTION OF BRADY BOULEVARD BETWEEN S. ZARZAMORA AND S. CALAVERAS LOCATED IN CITY COUNCIL DISTRICT 5.

WHEREAS, the Development Services Department staff (staff) received a City Council Request from Councilwoman Shirley Gonzales (District 5) to grant a memorial designation to a portion of Brady Boulevard between the cross streets of S. Zarzamora and S. Calaveras to honor the memory of Victoria Robles, the eldest daughter of Annette and Jimmie Robles, founder of Last Chance Ministries which is located on Brady Boulevard; and

WHEREAS, staff began implementing this request through the street naming/memorial designation process as required by Chapter 6 of the City Code; and

WHEREAS, staff forwarded this request to all City of San Antonio departments and outside agencies for review and acquiescence and no opposition has been identified; and

WHEREAS, staff conducted a technical review finding it to conform to City Code requirements for memorial designations; and

WHEREAS, staff properly posted and mailed notice of this request to attach the memorial designation to said street to abutting property owners, notice requirements for giving the memorial designation of the street have been satisfied in accordance with Chapter 6 of the City Code; and

WHEREAS, a community meeting was held on November 6, 2017, and the Planning Commission held a public hearing on November 13, 2017 and recommended approval through a motion to support the memorial designation of "Victoria Robles Memorial Way"; NOW THEREFORE,

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

**SECTION 1.** Brady Boulevard, located in City Council District 5, between S. Zarzamora and S. Calaveras is hereby given the memorial designation of "Victoria Robles Memorial Way." The location is more specifically depicted in **ATTACHMENT 1**. City staff is directed to provide appropriate signage to this effect.

**SECTION 2.** Funding for this ordinance in the amount of \$1,412.25 is available in Council District 5 NAMP funds as part of the Fiscal Year 2018 Budget.

**SECTION 3.** The financial allocations in this Ordinance are subject to approval by the Director of Finance, City of San Antonio. The Director of Finance, may, subject to concurrence by the City Manager or the City Manager's designee, correct allocations to specific SAP Fund Numbers, SAP Project Definitions, SAP WBS Elements, SAP Internal Orders, SAP Fund Centers, SAP Cost

Centers, SAP Functional Areas, SAP Funds Reservation Document Numbers, and SAP GL Accounts as necessary to carry out the purpose of this Ordinance.

**SECTION 4**. This Ordinance is effective immediately upon receipt of eight affirmative votes; otherwise, it is effective 10 days after passage.
