AN ORDINANCE

**AUTHORIZING THE FOLLOWING CONTRACTS ESTABLISHING
UNIT PRICES FOR GOODS AND SERVICES FOR AN ESTIMATED
ANNUAL COST OF \$292,000.00: (A) MOBOTREX, INC. FOR TRAFFIC
LIGHT MOUNTING ASSEMBLIES, (B) CHAMPION FLOORS, INC.
FOR WINDOW WASHING SERVICES AT THE CONVENTION
CENTER, AND (C) SCHNEIDER ELECTRIC SYSTEMS USA, INC. FOR
SUPPORT AND MAINTENANCE FOR THE FOXBORO I/A SERIES
SYSTEM THAT SUPPORTS THE CITY'S RIVERWALK FLOOD
CONTROL SYSTEM.**

WHEREAS, bids were submitted to provide the City of San Antonio with commodities and services on an annual basis for the terms of the contracts; and

WHEREAS, this ordinance approves the following contracts: (A) MoboTrex, Inc. for traffic light mounting assemblies, (B) Champion Floors, Inc. for window washing services at the Convention Center, and (C) Schneider Electric Systems USA, Inc. for support and maintenance for the Foxboro I/A Series system that supports the City's Riverwalk flood control system; and

WHEREAS, the bid submitted by General Traffic Equipment failed to meet the City's specifications and/or requirements for traffic light mounting assemblies; and

WHEREAS, the bids submitted by Tracy Cleaning Service and Wolfe Logistical Services failed to meet the City's specifications and/or requirements for window washing services at the Convention Center; and

WHEREAS, according to section 252.022(a)(7) of the Texas Local Government Code competitive bidding is not required for a procurement of items that are available from only one source; and

WHEREAS, this ordinance approves two low qualifying bid contracts and one contract procured on the basis of sole source; and

WHEREAS, all expenditures will be in accordance with the applicable fiscal year's budget approved by City Council; **NOW THEREFORE**:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SAN ANTONIO:

SECTION 1. The following bids to furnish the City with goods and services on an annual basis as shown on the attached bid tabulation sheets are hereby accepted, subject to and contingent

upon the deposit of all required bonds, performance deposits, insurance certificates and endorsements: (A) MoboTrex, Inc. for traffic light mounting assemblies, (B) Champion Floors, Inc. for window washing services at the Convention Center, and (C) Schneider Electric Systems USA, Inc. for support and maintenance for the Foxboro I/A Series system that supports the City's Riverwalk flood control system. The bid tabulation sheets are attached hereto and incorporated herein for all purposes as **Exhibit I**. Copies of the bids are available for inspection in the offices of the Purchasing Division of the Finance Department.

SECTION 2. It has been found and declared that the bid submitted by General Traffic Equipment for traffic light mounting assemblies failed to meet the City's specifications and/or requirements.

SECTION 3. It has been found and declared that the bids submitted by Tracy Cleaning Service and Wolfe Logistical Services for window washing services at the Convention Center failed to meet the City's specifications and/or requirements.

SECTION 4. Funds will be encumbered upon issuance of purchase orders and payment is authorized to the vendors identified herein. All expenditures will be in accordance with the Fiscal Year 2018 budget and such other appropriations necessary to fund the contracts through their terms as evidenced by subsequent ordinances.

SECTION 5. This ordinance is effective immediately upon passage by eight affirmative votes; otherwise it is effective on the tenth day after passage.
