# Global Cities Initiative | San Antonio

- 2012 First engagement with GCI and selected to develop an Export Strategy
- 2013 San Antonio Export Strategy
- 2014 Invited to be part of Trade & Investment Strategy pilot
- 2015 San Antonio Trade & Investment Strategy
- 2017 San Antonio selected as one of eight to participate in the development of a market prioritization framework by Brookings
- 2018 Present findings of the market prioritization framework analysis. Brookings to produce a summary report, toolkit with data sources, and proposed matrix.



## Challenge


Foreign direct investment and exports present substantial economic opportunities, but we lack the specificity to target our strategies and limited resources in a meaningful way.

Global network and sector analysis of existing and potential markets.





# 01 Cluster Analysis | San Antonio

## THE TASK

- Define and demonstrate that industry specialization is a top prospect for future growth.

## THE RESPONSE

- Cybersecurity - nationally distinct housing an emerging cluster of activity that came out of a strong and long-standing federal security / intelligence sector



## Industry-Specific Goal

Identify metros for cybersecurity ecosystem growth that yield measurable outcomes and guide resource allocation, time and focus.

## Strategy

Apply quantitative and qualitative data to prioritize foreign markets, at the metro level, around three core areas of engagement:

- export of cybersecurity products and services from San Antonio;
- foreign direct investment (FDI) attraction; and
- strategic collaboration and innovation exchanges.



## 02 Industry Cluster Links | Global

### THE TASK

- Identify the markets that show potential for economic linkages with cybersecurity.

### THE RESPONSE

- Matrix developed to attain overview of existing and new markets pulling in trade and investment data as well as initial connectivity / soft data.



## 03 Connectivity | Metro to Metro

### THE TASK


- Further assess foreign markets based on macroeconomic, political, and cultural factors.

### THE RESPONSE

- Matrix expanded to include additional macroeconomic factors, along with geography and cultural proximity.




